

**Michaels® Bonus Month Sweepstakes
OFFICIAL RULES**

No purchase necessary to enter or win. A purchase will not increase your chances of winning. Void where prohibited.

SWEEPSTAKES DESCRIPTION: The Michaels® Bonus Month Sweepstakes (the “**Sweepstakes**”) begins on February 1, 2025, at 12:00:01 a.m. Central Time (“**CT**”) and ends on February 28, 2025, at 11:59:59 p.m. CT (the “**Sweepstakes Period**”). Participation in the Sweepstakes does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Michaels Stores, Inc., 3939 West John Carpenter Freeway, Irving, TX 75063 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Open only to legal United States residents residing in the fifty (50) United States and District of Columbia, who are eighteen (18) years of age or older and have a valid Michaels Rewards account at the time of entry. It is free to enroll in Michaels Rewards (to enroll, visit www.michaels.com/rewards). Michaels Rewards accounts are subject to its Terms and Conditions. Employees, officers and directors of Sponsor, participating retailers, Comenity Capital Bank, their respective parents, subsidiaries, affiliates, distributors, agents, partners, sales representatives, advertising and promotion agencies (collectively, the “**Sweepstakes Entities**”) and the Immediate Family Members, and/or Household Members of each are ineligible to participate in the Sweepstakes or win a Prize and are not eligible to participate. HOW TO ENTER: There are two (2) methods of entry for this Sweepstakes as follows:

1. **Automatic Entry for Sweepstakes using your eligible Michaels Credit Card**– you will automatically receive one (1) entry into the Sweepstakes each time you use your Michaels Credit Card to make a Purchase transaction during the Sweepstakes Period.

2. **NO PURCHASE NECESSARY.** To enter by mail, without making a purchase, write the name of the Sweepstakes, your full name, full address (no P.O. boxes), email address, date of birth and telephone number on a 3x5 card and mail the card to: Michaels® Bonus Month Sweepstakes, PO BOX #457, Newark, NY 14513. Mail-in entries must be postmarked by February 28, 2025, and received by March 7, 2025. Mail-in entries must be legibly hand-written. No copies, facsimiles or mechanical reproductions will be accepted. Sponsor assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible or postage due entries or mail. Limit one (1) entry per outer stamped mailing envelope.

Limit one (1) entry per person per day regardless of number of Michaels Credit Card transactions made or method of entry. The Sweepstakes Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

WINNER SELECTION AND NOTIFICATION: On or about March 10, 2025, one (1) potential prize winner will be randomly selected by a representative of Sponsor from all eligible entries received in accordance with the deadlines stated in these Official Rules. The winner is considered a potential winner pending verification of their eligibility and compliance with the deadlines stated in these Official Rules. The potential winner will be notified by telephone and/or e-mail, using contact information associated with their Michaels Credit Card account, or included in their mail-in entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of mailing address, email address, and/or telephone number of entrants. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the Prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their Prize, and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of the Prize in accordance with the above procedure, after which the Prize may go unawarded if it remains unclaimed. If any potential Prize winner is found to be ineligible, or if they have not complied with these Official Rules or decline the Prize for any reason prior to award, such potential Prize winner will be disqualified, and an alternate Prize winner may be selected. **The odds of winning depend on the total number of eligible entries received in accordance with the deadlines stated herein.**

PRIZE:

GENERAL PRIZE CONDITIONS: Prize must be accepted as awarded or prize will be forfeited and awarded to an alternate winner. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. In the event Sponsor is prevented from awarding the Prize or continuing with the Sweepstakes as contemplated herein by any event beyond its control, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

DISPUTES/GOVERNING LAW: Except where prohibited by law, Entrant agrees that: (1) all disputes, claims and causes of action arising out of or connected with this Sweepstakes or the prize will be resolved individually, without resort to any form of class action, and Entrant consents to the personal jurisdiction of the appropriate federal or state court located in Dallas County, Texas for such purpose; and (2) all claims, judgments and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees.
