Narragunnawali: Reconciliation in education led by Reconciliation Australia

Commenced: June 2022 Duration: 5 years Commitment: US\$6 million* Country: Australia

Supporting schools and early learning services to teach about and take action towards reconciliation between non-First Nations Australians and Aboriginal and Torres Strait Islander peoples.

Progress to date

The project has supported more than 12,000 or 44 per cent of all Australian schools and early services to champion reconciliation through engaging with the Narragunnawali Reconciliation Action Plan framework. Through this work, teachers and educators are able to access resources to deepen their own practice, while engaging the hearts and minds of future generations to contribute to the reconciliation movement. The biennial Narragunnawali Awards are a celebration of the strengthening movement of reconciliation in education around Australia.

Supporting self-determined governance for Indigenous development outcomes led by the Australian Indigenous Governance Institute

Building a future Australia where Indigenous Peoples, communities and nations can pursue and exercise their right to self-determination and economic development through strong self-governance. Australian Indigenous Governance Institute (AIGI) is connecting Indigenous Australians to world-class governance practice, resources and professional development to meet their self-determined governance needs.

Progress to date

AIGI continues to walk alongside Indigenous groups around Australia to strengthen two-way governance with almost 1,500 individuals receiving AIGI training. The online Indigenous Governance Toolkit now has 100,000 users from Australia and internationally and is cited as "unique and unmatched".

Indigenous Governance led by Reconciliation Australia

Country: Australia

Showcasing self-determination and progressing reconciliation by recognizing, supporting and celebrating strong Aboriginal and Torres Strait Islander governance and self-determination.

Progress to date

Reconciliation Australia (RA) enhances two-way governance in First Nations organizations by facilitating ways to share knowledge and promote best practice, supporting their contribution to policies and programs affecting them and enabling collaboration between Indigenous Governance Awards finalist organizations and non-Indigenous organizations with Elevate Reconciliation Action Plans. As part of this work, RA developed the Indigenous Governance Awards which are the first of its kind to recognize best practice in two-way governance. The awards have grown to attract applications from more than 100 Indigenous organizations around Australia.

A growing community of practice is raising awareness at events such as the United Nations' Permanent Forum on Indigenous Issues. The first cohort of young Indigenous leaders will begin their collective leadership and development journey in mid-2024. Through these activities, Ban Ki-Moon is working to influence current decision makers and mobilize the next generation of leaders.

Bringing together government, Indigenous, charitable, corporate and other partners to make it easier for Indigenous communities to access funding and other resources for on the land community projects and initiatives in the Northwest

Progress to date

Territories of Canada.

The Collaborative was established in 2015 and has recently seen BHP Foundation join as a funding partner, along with an administrative team and community advisors appointed by regional Indigenous governments to reflect local priorities and ways of working. The Collaborative opened a funding round in late 2023 where just under CAD\$1 million was awarded through 40 different grants to communities across the territory for a variety of initiatives such as youth groups, cultural camps and land skills.

Supporting Indigenous Language Revitalization led by the University of Alberta

Commenced: Mar 2021 **Commitment: US\$9 million Duration: 6 years** Country: Canada

Transforming and strengthening the capacity of Indigenous-led language revitalization by increasing skills, shifting attitudes and behaviours, and supporting community-driven and system investment in language revitalization.

Progress to date

Supporting Indigenous Language Revitalization (SILR) is working to integrate language revitalization approaches and tools into policy and practice in communities and the education system. For example, more than 1,000 youth and 2,700 students have been reached through support for language-based activities on campus, in communities and online. SILR is also working with 40 communities engaged in Community-Centred Collaborative Agreements, each creating and participating in unique Indigenous language revitalization initiatives.

Fostering collaboration to implement innovative solutions to strengthen resilience in at least 20 fishing communities along Chile's coast where more than 140,000 fisher folk are dependent upon sustainable fisheries.

Progress to date

Already, the Chilean Communities Network of Marine Protected Areas (REDCAMP) has been formalized with Fundación Chile's support and a collaboration agreement reached in territories that cover 85 per cent of the protected sea along Chile's coastline. Recently, Capital Azul supported the inauguration of a grassroots TURF-Reserve in Cachagua to protect marine biodiversity.

STEM Together led by the Commonwealth Scientific and Industrial Research Organisation

Working to create a more inclusive STEM ecosystem and workforce, the project helps students from underrepresented groups and supporters build capability, confidence and connection with STEM. STEM stands for Science, Technology, Engineering and Mathematics.

Progress to date

91 per cent of 'Young Future Shapers' reported an increased awareness of STEM study and career options, while 90 per cent increased their transferable STEM skills. An initiative to train industry and community organizations to engage local students in STEM learning is set to strengthen the ecosystem. The design of a data analytics program to highlight barriers and enablers of STEM engagement is underway.

Right care, first time, where you live led by the Brain and Mind Centre of the University of Sydney

Commenced: Jan 2021 Duration: 6 years Commitment: US\$8.8 million
Country: Australia

Establishing a novel, place-based youth mental health decision-making model to provide the right care, first time, to get young people back to school, back to work, and thriving in their communities.

Progress to date

To improve the mental health and well-being of young people, this project builds community capacity to use systems modeling and simulation for effective decision making. It coordinates mental health care delivery, enables more effective advocacy for better investment in mental health and creates a sustainable, integrated system for monitoring and evaluation. Data models have been rolled out to three of eight local community sites, with another two sites in development. Youth contributors cite their participation as a critical channel to strengthen their agency and mental health.

Addressing youth mental health in policy and practice through evidence and economic analysis to support attitude and policy change among government, private sector and non-government organizations.

Progress to date

The Matilda Centre's impactful submission to the Measuring What Matters Framework consultation resulted in material changes to the national framework and subsequently opened quarterly dialogue with Federal Treasury to influence implementation of Australia's first well-being framework. The project's analysis of international leading practice will inform future economic modeling and policy advice. It will also publish new guidelines on youth participation in mental health which will be shared with key actors including government.

A national collaboration convening the Early Years sector to map the system and co-create a vision and action plan to improve early childhood development outcomes for children experiencing disadvantage and vulnerability.

Progress to date

Early Years Catalyst mapped the early childhood development system with over 300 people across the sector, nationally, to identify a desired state including key areas for change. A first of its kind in Australia, the outputs have been influential with several philanthropies using the findings to frame their strategy. There is broad alignment between the critical focus areas for change identified by the Early Years Catalyst and the framing of the Federal Government's Early Years Strategy.

Enabling the teaching of Computer Science in the Chilean public school

Progress to date

IdeoDigital has provided training in Computer Science to more than 900 teachers who have taken their learnings to the classroom, benefiting 13,325 public students across 14 regions in Chile. IdeoDigital has also achieved a key advocacy goal with the announcement by the Chilean Ministry of Education to include Computer Science in the country's new curriculum from 2026. The aim is to make programming, computational thinking, robotics, artificial intelligence and emerging technologies mandatory education across the school system.

An innovative alliance aiming to transform the education and teaching approach in Chile so that children and young people in the public education system learn the essential skills needed for 21st century society and jobs.

Progress to date

In early 2024, the Collective Effect alliance launched a US\$3 million competitive fund to support civil society organizations to strengthen their capacity to scale innovative educational projects. Eight innovative educational projects in Chile were chosen to receive support from the Collective Effect fund and to join a six month acceleration program. These organizations will now receive financial and technical support to accelerate transformative change in the public education system.

Progress to date

Teach For All has grown from a network of 48 partners and 60,000 alumni in 2007 to over 60 partners and 94,000 alumni working across 650 communities. Building from the work of the Global Learning Lab, Teach For All will be using the teaching and learning best practice gathered over five years, to launch a Global Institute for Transforming Education which will offer training and development to teachers and school leaders.

Millions Learning: evidence and innovation to scale impact led by Brookings Institution's Center for Universal Education

Publishing research that ensures decision makers have more actionable evidence and practical guidance on how to scale effective education practices, are better equipped to identify and understand innovative practices that have the potential to transform education progress, and use data effectively to improve learning outcomes.

Progress to date

The project conducted extensive research with local partners in five countries, providing practical recommendations for scaling programs in different contexts. It collaborated with governments in three countries to develop and pilot a tool for costing interventions for children and youth. Additionally, it has launched digital tools for real-time data collection for policymakers and other stakeholders. The project also co-created and shared resources with 49 organizations in over 20 countries, based on surveys from nearly 25,000 parents and over 6,000 teachers.

Developing new tools and resources to increase the impact of more than \$4 billion invested annually by businesses in education, and encourage more businesses to make education a sustainability priority.

Progress to date

This project has grown to include 59 active businesses globally. It provides a guide to help businesses understand the education sector and has created a playbook to align educational initiatives with ESG strategies, following prominent ESG reporting frameworks such as the Global Reporting Initiative and the Sustainability Accounting Standards Board. An evaluation found 75 per cent of global education stakeholders who were part of this initiative enhanced their capacity to take actions and decisions based on evidence.

A platform for young leaders to play a more active role in finding solutions for the education crisis in Africa. The Africa Evidence Youth League (AEYL), set by the Africa Evidence Network, provides a platform for emerging young leaders to share ideas, build connections and find ways to improve the use of data and evidence in decision-making practices.

Progress to date

In its pilot phase, AEYL is bringing together a dynamic group of 45 young people from 15 different African countries, united by their shared interest in strengthening the continent's education system through the use of evidence and data. This includes researchers, monitoring and evaluation experts, lecturers, policymakers, and teachers, among others.

Providing marginalized women access to quality learning, entrepreneurship and employment outcomes through second-chance education and vocational learning.

Progress to date

UN Women established more than 90 learning hubs, enrolling more than 77,000 women across six countries. To date, 72 per cent women who enrolled have graduated and of these, 36,373 women (65 per cent) now earn an income due to their participation. An outcomes-based funding mechanism is being developed in Mexico to support the sustainability of the project using local philanthropy and government funding.

Building a global evidence ecosystem for teaching led by the Education Endowment Foundation

Putting robust and reliable evidence into the hands of school leaders, teachers, and education policymakers by generating new and rigorous evidence, making that evidence accessible, relevant and actionable, and building a global network of evidence brokers to collaborate and share best practice.

Progress to date

This project takes the success of Education Endowment Foundation (EEF)'s evidence ecosystem from the English school system to other systems around the world. It has developed and implemented 12 high quality trials across five partnerships in eight countries to grow the knowledge base about what works to improve learning outcomes for children and young people. Additionally, EEF developed and launched a global network of education evidence-generating organizations, called the Education for Evidence Network, to share knowledge, experience, and tools across countries.

Building the largest Indigenous-led connected conservation network on Earth to keep Australia's outback healthy for the benefit of future generations.

Progress to date

Indigenous Desert Alliance (IDA) has made a pivotal shift in desert land management and Indigenous-led environmental stewardship. The Indigenous-led member-based organization supports desert ranger teams with connection and capacity across more than one-third of the Australian continent. The BHP Foundation's commitment stands as the single largest private investment in the sector, enabling the IDA to work with the more than 60 Indigenous ranger groups in these desert areas, to coordinate integrated land management activities to look after country and deliver a range of economic, social, cultural and environmental outcomes. It is a model for ground-up initiatives driven by Indigenous priorities and is proof of the power of centering Indigenous voices in environmental management, which will shape future collaboration across the desert.

Keeping the deserts connected led by Indigenous Desert Alliance

A thriving Indigenous network to protect the natural and cultural values of Australia's desert region.

Progress to date

As the peak network for Indigenous rangers, the Indigenous Desert Alliance (IDA) supports Indigenous-led land management activities which facilitates cultural and biodiversity outcomes for the Australian desert and its people. The IDA runs the world's largest Indigenous fire management program (by area), engaging 32 ranger teams in the Right Way Desert Fire program. It has created the first Indigenous-led species recovery plan for the Great Desert Skink, funded by the Australian government. The IDA has also established the Indigenous Desert Alliance Foundation, providing funding for land management priorities and cultural stewardship determined by Indigenous ranger teams.

Forest conservation in Manitoba's Boreal led by Nature United

Working with First Nations to create a new model for land and water management and a resilient future for the people and nature in Manitoba's Boreal forest. The project supports Indigenous leadership and authority over natural resources decision making and management within the nine million hectare Forest Management License Area.

Progress to date

Through support of the project, communities are establishing land use plans that identify the community's vision and goals for their territories. Other community-led work includes guardian programs, moose and water quality monitoring and engagement in the 20-year Forest Management Planning Process. The project is also working with communities to explore opportunities for sustainable financing for Indigenous stewardship in Northern Manitoba.

El Boldo to Cantillana Conservation Corridor led by Fundación Tierra Austral

Achieving transformative conservation of Chile's Mediterranean habitat by demonstrating how to establish land conservation in perpetuity through Derecho Real de Conservación (DRC). DRCs are the Chilean equivalent of conservation easements which enable private landowners to take long-term action to protect the sustainability of their properties.

Progress to date

Fundación Tierra Austral has set up nine DRCs in the Boldo to Cantillana Corridor protecting more than 17,500 hectares. The DRCs use locally-led practices to engage the surrounding community in recreation, employment, and access activities. They continue to transform land conservation, establishing a public-private coalition of conservation organizations in Chile to share best practices.

Working to turn the tide against deforestation in one of the world's biodiversity hotspots in the Peruvian Amazon, by empowering Awajun Indigenous communities.

Progress to date

Conservation International has co-created with FERIAAM (the Federation of Awajun Communities in Alto Mayo) a model for enduring conservation and development in the landscape which considers governance, culture, environmentally sustainable economic activities, and conservation and restoration all equally important. FERIAAM is providing greater leadership, backed by governance and training, with the communities that are its constituents, as well as with external actors such as the Ministry of Environment.

Providing a standardized approach for assessing and communicating the sustainability performance of landscapes where key commodities are produced.

Progress to date

Starting with an idea, Rainforest Alliance and Conservation International have designed and field-tested the LandScale system. Results in this final year of implementation has seen 22 paying "Validated by LandScale" customers; 32 landscape initiatives active globally, with profiles on the platform covering a combined area of almost 27 million hectares; and five formal partnership agreements in place to grow and leverage LandScale's reach and credibility.

A guide is being developed with insights from a literature review of lessons learned from other nature markets and targeted interviews with government representatives across Australia, Brazil, Canada, Colombia, Ecuador, Peru and the Philippines. Feedback on the guide will be sought from interested governments at COP16, and further collaboration opportunities explored.

Resilient Reefs Initiative era 1 led by Great Barrier Reef Foundation

Enhancing the resilience of the world's most treasured coral reef sites and the communities that depend on them to adapt to climate change and local threats.

Progress to date

The first phase of the Resilient Reefs Initiative co-designed and is delivering 33 resilience projects, at least half of which were designed and delivered with Indigenous Peoples and front-line communities across four bioregions (Belize, New Caledonia, Ningaloo and Palau). The project funded, connected and built capacity for more than 75 local delivery partners and four new reef resilience strategies were co-designed and released with government and community partners. As a result, these sites have a better understanding of their climate threats and opportunities, a pipeline of projects and clear plan of action for mitigating risk and building resilience, an engaged community to sustain this work, and greater government capacity to develop partnerships with global funders and innovators.

Resilient Reefs Initiative era 2 led by Great Barrier Reef Foundation

Commenced: Apr 2024 Duration: 5 years Commitment: US\$10 million

Countries: Pacific Island Countries and Territories

Supporting reef ecosystems and coastal communities across the Pacific to accelerate adaptation to climate change and local threats. The Pacific is home to 27 per cent of the world's coral reefs but is the most underfunded region despite being the most vulnerable to climate impacts. With support of strong regional governance and vision, success in this region has the most potential to influence the global agenda.

Progress to date

The Great Barrier Reef Foundation has started work on identifying locations for three Resilience Hubs and planning for a pipeline of actions and funding generated in four Accelerator programs. Work is on track to deliver increased resilience of reefs and communities; to support the Pacific region to be more connected, equipped and empowered to deliver adaptation and restoration solutions at scale; and to unlock funding to support a large pipeline of project led by Indigenous Peoples and front-line communities.

To exchange best practice and knowledge in carbon projects and build capability, community leaders, Indigenous leaders, technical experts and allies were brought together from Australia, Canada and South America for a four day exchange. Participants visited Peru's Alto Mayo forest to learn how the Awajun community stewards sustainable land management practice through the Tajimat Pujut carbon project (Awajun for 'Good Life').

Transformative Governance: Collaborative Leadership Initiative led by the Centre for Indigenous Environmental Resources

Progress to date

The project has launched two innovative pilots: the Natural Infrastructure Champions Network which brings together key champions from the Canadian Prairies for knowledge and experience sharing as well as opportunity identification, and a policy pilot to influence municipal statutory plans across the Prairies. The Natural Infrastructure for Water Solutions team participated in a multistakeholder process with Alberta WaterSMART to prioritize water infrastructure projects in southern Alberta, and successfully advocated to embed natural infrastructure options in a major water infrastructure planning process.

Empowering decision makers and communities to generate insights, inform decision making, and inspire innovative solutions by modernizing public water data infrastructure.

Progress to date

Internet of Water (IoW) is working with government and stakeholders to create and adopt integrated modern data infrastructure systems that will enable data-backed decision making for over 460,000 bodies of water in the United States. IoW has developed a suite of tools to enable easy access to water data and collaborative approaches to data extraction, monitoring and display. Notably, it secured a landmark agreement with the United States Geological Survey to support and validate one of these tools, the Geoconnex platform, for five years.

Advancing water equity and resilience led by Pacific Institute

Generating evidence of effective water equity and resilience strategies and promoting awareness and uptake of those strategies to strengthen water equity and resilience in the United States.

Progress to date

In 2023, three place-based assessments were completed on water efficiency and reuse, stormwater capture and use, and water equity - access and sanitation. Pacific Institute co-founded Vessel, the first national United States water access and sanitation coalition, uniting 12 organizations collaborating for fairer access to water in the United States. In May 2024, Vessel's first convening brought together 150 organizations to promote cross-sector collaboration and set targets for addressing the water crisis.

For example, ACDS launched the Financial Transparency and Integrity (FTI) Community of Learning and Action that conducts research and supports collaboration to improve beneficial ownership and procurement ecosystems.

This new project, launched at the International Anti-Corruption Conference in June this year, brought together beneficial ownership advocates and BHP Foundation partners to share lessons of what has worked and how to manage challenges when advocating for beneficial ownership transparency reforms. The project will now focus on building globally-relevant resources while progressing reforms in Canada.

Examples include a land return project in Tanzania; Indigenousled negotiations in Guyana on infrastructure agreements; and support towards the official designation of an Indigenous Protected and Conserved Area in British Columbia, Canada.

Progress to date

RISE Ukraine focuses on coalition building, awareness raising, advocacy and digital tools development to embed open contracting principles into Ukraine's recovery and reconstruction planning and implementation. The coalition played a key role in shaping a fully transparent electronic platform to coordinate the implementation of all reconstruction projects. In 2023, the system supported 1,560 reconstruction projects, around 500 communities, 19 regional administrations, five ministries and 24 recovery services. It also supports buy-in for donors and has received international recognition.

To provide better public goods, works, and services to citizens in resource-rich countries through procurement reforms that enable fair, inclusive and climate-sensitive public contracting.

Progress to date

Open Contracting Partnership is improving data availability and quality, strengthening government capacity and increasing civil society engagement in resource-rich countries. Examples include: together with CivicDataLab, 6.5 million people are benefiting from improved flood-related spending in Assam, India, as a result of a new data tool developed with CivicDataLab. In Argentina, an inclusive infrastructure project with Asociación Civil por la Igualdad y la Justicia has directly benefited 69,700 residents. And in Ekiti, Nigeria, women-led businesses registration in the official state public procurement system has increased by 43 per cent to a total of 158 businesses, winning a total of 47 contracts.

Reducing corruption along the natural resource value chain through research and field work that advance transparency, accountability, and participation.

Progress to date

Leveraging Transparency to Reduce Corruption (LTRC) positioned itself as a strategic knowledge and research partner to organizations. LTRC informed policy conversations, facilitated the exchange of knowledge and peer learning, and developed road maps for continued progress on critical topics such as advancing beneficial ownership transparency. For example, it produced nearly 100 knowledge products and developed the Transparency, Accountability, and Participation (TAP)-Plus framework, which is cited as a critical resource for addressing challenges and opportunities in natural resource governance.

This sponsorship supported Global Schools Forum's Annual Meeting that brought together nearly 140 participants from over 30 countries representing its global community of nonstate organizations, funders, policymakers and researchers. Global Schools Forum also hosted a Secondary Education study tour for 22 participants from 14 organizations in eight countries. These events enabled participants to share learning, strengthen leadership, and provide a platform for pursuing collaborative partnerships on education.

Congreso Futuro

Congreso Futuro is one of the most recognized free science dissemination platforms in Latin America. It seeks to provide public policy developers with a comprehensive view of the governance, planning and ethical concerns presented for the workforce of the future due to technology development. In FY24 activities attracted 50,000 attendees to hear from more than 115 exhibitors from 20 countries. The events were held across 16 regions of Chile and enabled more than 3,700 students to participate through an education program.



Los Creadores

Los Creadores is a national school innovation competition in which students from all regions of Chile are invited to participate by creating projects aimed at solving community challenges using technology. Supported by BHP Foundation since 2018, this initiative has reached more than 8.000 children and teenagers who stand out for using technology to develop a project which can improve the quality of life for people, their families, their surroundings, their country and the world.
