

## **Training**

Everyone working on a Sky Original Commission, including cast and crew, are expected to complete various online learning courses, which sets out the level of behaviour we expect in any workplace environment.

All information on individuals and training outcomes will be compliant with Data Protection requirements. Further information can be found in our privacy policy <a href="here">here</a>.

A full list of courses can be found below, comprising of mandatory and suggested courses.

## **ScreenSkills Training Passport**

You will need to nominate one or more "verifiers" who ScreenSkills will train on how to administer their platform. Your Production Exec will set this up a couple of weeks before rollout of the courses needs to begin. Your verifier will need to track and report to Sky on completion rates, with a target of 100% completion.

All individuals must complete the training in the <u>Work Well series</u> and <u>Safeguarding For All</u> via the ScreenSkills website as part of their onboarding at the earliest opportunity. Please see below for more information.

## **Leadership and Management Training**

We require all Heads of Department and managers on productions to complete the <u>ScreenSkills Leadership and Management training</u>.

This is to be organised by the production company and be completed before a production starts (or on an annual basis). ScreenSkills will report back to Sky on which productions have completed training for internal awareness and audit purposes.

## **Albert Training**

There are a few courses that are mandatory to achieve Albert certification. For more information, please see below.
