


# II. February 22, 2022, email from Arctic Glacier to broker (Delarvas).

I look forward to receiving the 3 quotes you are sending to Owner from local riggers/crane companies ... on the equipment removal. I will select a company that meets your approval to undertake the removal under my supervision ...and entirely at Broker's expense -once I have looked at their quotes and done my homework. Look forward to getting this done.

#### III. April 12, 2022, email from Broker to Owner.

Kamloops- said you have quotes from BC riggers/ crane company who Broker might subcontract to remove under my supervision the ice makers & refrigeration.

### V. April 20, 2022, email from Owner to Broker.

Current plan is to arrive next Tuesday May 24-2022 morning to begin removal. I have contacted multiple contractors -crane service providers in/near KAMLOOPS but have not yet confirmed which local company is willing/able to provide the rigging services under my supervision- with adequate Gen Liability and Workman's Compensation insurance.

I left a message with Refrigeration mechanic B Refrigeration. After seeing their quote – looks like they want more \$\$ than I am willing to pay... but waiting to hear back from them.

Are there other small contractors that have insurance that I should call to discuss using two of their guys under my supervision to undertake this removal?



#### VI. May 17, 2022, email from Broker to Owner.

Is acquiring ice makers and related refrigeration from a packaged ice plant (closed-no longer operating) ... in Kamloops Canada (owned by ARCTIC Equipment removal is scheduled for May 24-2022. I am hiring a local rigger to do the removal under my supervision.

Good morning. I am in Kamloops. What time may I come to the plant?




