

MoneyHero “Starr Companies旅遊保險限時優惠” 之條款及細則(「條款及細則」)

1. 根據本條款及細則，合資格用戶(定義如下)於推廣期內(定義如下)，透過MoneyHero的網站成功投保Starr Companies之單次旅遊保險(以下稱為「指定保險產品」)，及每張保單之折後保費須滿港元300或以上，方可獲取50港元HKTVmall電子購物禮券(「推廣獎賞」或「電子禮券」)。
2. 推廣期
「MoneyHero “Starr旅遊保險限時優惠”」(「推廣活動」)由MoneyHero Insurance Brokers Limited(「**MoneyHero**」)舉辦，並將於2023年11月27日下午6時至2023年12月11日下午6時(包括首尾兩天)舉行(「推廣期」)。
3. 參加資格
如要成為可獲取推廣獎賞的「合資格用戶」，參加者必須：
 - a. 是[18歲或以上的香港居民];及

1. Eligible Customers (each as defined below) who successfully purchase a travel insurance product (Single Plan) of Starr Companies within the Promotion Period (each as defined below) through MoneyHero, with a premium of HK\$300 or above (after applying any discounts), will receive a HKTVmall e-Voucher of face value HK\$50 ("**Promotion Reward**" or "**e-Voucher**").

2. Promotion Period
