

「額外\$3,800 現金回贈」優惠條款及細則 (“優惠”):

1. 是次優惠推廣期由 2022 年 5 月 7 日起至 2022 年 6 月 30 日止(包括首尾兩日) (“推廣期”)。
2. 全新客戶凡於推廣期內經 [www.MoneyHero.com.hk](http://www.MoneyHero.com.hk) 遞交業主私人貸款申請，並成功提取新貸款額達 HK\$200,000 及供款期達 24 期或以上，即可獲享額外 HK\$3,800 現金回贈(“現金回贈”)。優惠須受提取貸款時所簽署的合約上之條款及細則約束。

## Terms and Conditions for Extra \$3,800 Cash Rebate (“Promotion”)

2. During the Promotion Period, New Customers who have successfully applied for and have drawn down on the Property Owner Loan through [www.MoneyHero.com.hk](http://www.MoneyHero.com.hk) with a net loan amount of HK\$200,000 and a minimum loan tenor of twenty-four instalments, shall be eligible to receive an extra HK\$3,800 cash rebate (the “rebate”). The Promotion is subject to the terms and conditions of signed agreements for the loan application.
3. For purpose of these terms and conditions, a “New Customer” means a customer who has never applied for any loan from WELEND LIMITED (“WELEND”) prior to the application of the present designated loan.
