U.S. Paralympics Swimming GAMES STAFF SELECTION PROCEDURES 2023 Parapan American Games

January 24, 2023

Amended July 10, 2023

These procedures provide for selection of U.S. Paralympics Swimming's **Games Staff** [see following table for a list of positions] for the 2023 Parapan American Games (the Games). However, accreditation allocation is not guaranteed and will be based on final USOPC credential allocation and overall team size. Responsibility of payment for allocated accreditations will be determined by the USOPC and U.S. Paralympics Swimming.

1. List of specific Games Staff position(s) that U.S. Paralympics Swimming is requesting:

Games Staff Role	Responsibility		
Team Leader (1)	Responsibility: Serve as primary point of contact and liaison between the USOPC and U.S. Paralympics Swimming before, during and after the Games.		
Assistant Team Leader (1)	Responsibility: Assist with all team administration, paperwork, forms, and entries; assist the Team Leader with logistics, discipline, and Games requirements.		
Coach: Head Coach (1), Assistant Coach (up to 8)	Responsibility: Prepare athletes/team for success on the field of play.		
Medical Personnel: PT/ATC, MD (up to 3)	Responsibility: Provide appropriate sport specific medical care for the team.		
Sport Science Professional: Dietitian (1)	Responsibility: Provide nutrition support leading up to and during competition and manage athlete recovery station.		
Mental Health Professional: Sport Psychologist (1)	Responsibilities: Work with individual athletes to develop and strengthen mental skills, work with the team to build trust and cohesion and work with coaching staff to provide targeted resources for athletes, team and coaches.		
Team Support Staff focused on athlete accessibility needs (i.e., personal care assistants)	Provide customized support for athletes as required (i.e., supervision, wayfinding, help with everyday care and/or activities of daily living).		
Technical Personnel: Sport Science Support (up to 2)	Responsibility: Manage all video and race analysis and athlete recovery station.		

2. U.S. Paralympics Swimming's criteria for the above-listed Games Staff position(s) (attach a job description, if any):

All Games Staff must:

- 2.1. Undergo a background screen in accordance with the current <u>USOPC Games</u>
 <u>Background Check Policy & Procedures</u> prior to nomination.
 - 2.1.1. Should a nominee experience any event between the time the background check is conducted and the relevant Games that may change his/her background check status, the nominee must inform the U.S. Paralympics Swimming and/or the USOPC.
- 2.2. Possess a valid passport that does not expire until at least six months after the conclusion of the Games.
- 2.3. Have the ability to work effectively with the USOPC.
- 2.4. Have strong administrative, communication and organizational capabilities/skills as applicable for the Games Staff role.
- 2.5. Be responsible for Team's adherence to all rules regarding personal conduct at the Games.
- 2.6. Fulfill all duties and requirements of the USOPC including attendance at USOPC Games related meetings, as applicable.
- 2.7. Be available for entire duration of the Games, if requested.
- 2.8. Have U.S. Paralympics Swimming's approval prior to making any financial decisions regarding the Team.
- 2.9. Possess high level, specific technical and tactical knowledge of the sport as needed for the Games Staff role.
- 2.10. Have thorough knowledge and understanding of the IF rules and regulations governing the sport as needed for the specific role.
- 2.11. Demonstrate ability to establish harmonious relationships with athletes and other Team personnel.
- 2.12. Be in good health and able to withstand the physical rigors of traveling with and working with the Team.
- 2.13. Be listed on U.S. Paralympics Swimming's Long List.
- 2.14. Successfully complete all Games Registration requirements by stated deadlines.
- 2.15. Participate in the appropriate anti-doping training as required for the Games Staff role by stated deadline.
- 2.16. Successfully complete the appropriate U.S. Center for SafeSport's online training module(s) by stated deadline.

In addition to criteria 2.1 through 2.12 above, Team Leader and Assistant Team Leader must:

- 2.17. Fulfill all duties and requirements of the USOPC including attendance at USOPC Games related meetings.
- 2.18. Have strong administrative, communication and organizational capabilities/skills.
- 2.19. Have U.S. Paralympics Swimming's approval to make financial decisions regarding the Team.
- 2.20. Have previous administrative, international relations and/or Team Leader experience at an international competition.
- 2.21. Have previous experience at a major international swimming championship.
- 2.22. Have thorough knowledge and understanding of the World Para Swimming rules and regulations governing the sport.

- 2.23. Have knowledge of U.S. Paralympics Swimming.
- 2.24. Have ability to interact with coaching staff, athletes, U.S. Paralympics and USOPC Administration, and World Para Swimming personnel.
- 2.25. Be available for any camps hosted for the Games Team.

In addition to criteria 2.1 through 2.12 above, Coach(es) must:

- 2.26. Have thorough knowledge and understanding of the World Para Swimming rules and regulations governing the sport.
- 2.27. Possess a high level of specific technical and tactical knowledge of the sport.
- 2.28. Have previous experience and proven ability coaching teams at the national and international levels.
- 2.29. Be a current coach member of USA Swimming with all certifications and requirements valid.
- 2.30. Agree to and sign the guidelines established by the Director for all staff and all team members.
- 2.31. Respond to administrative requests from U.S. Paralympics Swimming in a timely manner and report any changes to information on file.
- 2.32. <u>Assistant and Head Coach experience:</u> Be the primary coach of an athlete member of the 2023 World Championships Team and/or the 2023 Parapan American Games Team.
 - 2.32.1. Eligible Assistant Coaches (who are not current USOPC employees working with the U.S. Paralympics Swimming program) must have been a coach, head or assistant, on a 2019, 2020, 2021, 2022, 2023 U.S. Para Swimming International/National Team trip, or be a primary coach of an athlete member of the 2023 Parapan American Games Team.
 - 2.32.2. Eligible Head Coaches (who are not current USOPC employees working with the U.S. Paralympics Swimming program) must have prior experience as a Head Coach on a U.S Para Swimming International/National Team trip or as a Head Coach with a club or collegiate swim team for a nominated USA Swimming travel team.
- 2.33. Be available for any camps hosted for the Games Team.
- 2.34. Possess a high level of specific technical and tactical knowledge of the sport.

In addition, Medical Personnel must:

- 2.35. Meet the minimum criteria defined in the <u>USOPC Sports Medicine Provider</u> <u>Credentialing Policy</u>.
- 2.36. Possess the appropriate professional certifications.
- 2.37. Pass a medical credential review in addition to the approved USOPC Games
 Background Check, which will be a combined check managed through USOPC Sports
 Medicine (separately arranged background checks will not be considered).
- 2.38. Meet the required experience and proficiency levels as determined by USOPC Sports Medicine. (www.teamusa.org/medicalvolunteer)
- 2.39. Complete the mandatory Games training prior to the Games.

- 2.40. Be approved for nomination through the USOPC's Sports Medicine Division.
- 2.41. Fulfill all requests and meet deadlines for any required information or documentation such as the submission of a temporary licensing application (to practice medicine at the Games) and medical equipment submission requirements.
- 2.42. Be available for any camps hosted for the Games Team.

In addition to 2.1 through 2.12, Sport Science Professional(s) must:

- 2.43. Meet the minimum criteria defined in the <u>USOPC Sport Science Provider</u> Credentialing Policy (see "Additional Resources").
- 2.44. Possess the appropriate professional certifications.
- 2.45. Pass licensure/credential review in addition to the approved USOPC Games Background Check, which will be a combined check managed through USOPC Sport Performance (separately arranged background checks will not be considered).
- 2.46. Possess appropriate experience relative to the position/field of practice for which they may be nominated.
- 2.47. Fulfill all requests and meet deadlines for any required information or documentation such as the submission of a temporary licensing application (to provide services at the Games).
- 2.48. Be available for any camps hosted for the Games Team.

In addition to 2.1 through 2.12 above, Mental Health Professional(s) must:

- 2.49. Meet the minimum criteria defined in the <u>USOPC Sports Medicine Provider</u> <u>Credentialing Policy</u>.
- 2.50. Possess the appropriate professional certifications.
- 2.51. Pass licensure/credential review in addition to the approved USOPC Games
 Background Check, which will be a combined check managed through USOPC Sport
 Medicine (separately arranged background checks will not be considered).
- 2.52. Possess appropriate experience relative to the position/field of practice for which they may be nominated.
- 2.53. Fulfill all requests and meet deadlines for any required information or documentation such as the submission of a temporary licensing application (to provide services at the Games).
- 2.54. Be available for any camps hosted for the Games Team.
- 2.55. Psychology licensure with evidence of fulfilling the sport psychology requirement as stated by APA, CMPC certification or USOPC registry membership.

In addition, Team Support Staff for athlete accessibility needs (i.e., personal care assistant) must:

- 2.56. Have sport specific expertise working with persons with disabilities.
- 2.57. Have experience working with athletes and coaches in a competition setting.
- 2.58. Be able to assist athletes/disability groups with daily personal care as necessary.
- 2.59. Assist with all aspects of the Team during travel, training, competition and downtime as needed.
- 2.60. Possess appropriate experience and/or professional certifications based on athlete(s) needs.

2.61. Be available for any camps hosted for the Games Team.

In addition, Technical Personnel must:

- 2.62. Have knowledge of the process and protocols for lactate clearance testing, race analysis, and athlete recovery.
- 2.63. Have experience and proven ability working with teams at the national and international levels.
- 2.64. Be available for any camps hosted for the Games Team.
- 3. Intended method of identifying the pool and selecting the candidates to be considered for the Games Staff position(s):

Assistant Coaches:

The U.S. Paralympic Swimming Director will contact coaches who are eligible and meet the criteria outlined in Section 2 on or before May 19, 2023, to gauge their interest in a coaching position for the 2023 Parapan American Games team staff. Coaches who are interested will be added to the 2023 Parapan American Games coaching pool.

Head Coach:

The U.S. Paralympics Swimming Director will contact coaches who are eligible and meet the criteria outlined in Section 2 on or before May 19, 2023, to gauge their interest in the head coaching position for the 2023 Parapan American Games team staff. Coaches who are interested will be added to the 2023 Parapan American Games coaching pool.

Additional Games Staff Positions:

U.S. Paralympics Swimming will not solicit applications for the Games Staff position(s) listed above. U.S. Paralympics Swimming will contact individuals with an extensive background and history in working with the U.S. Paralympics Swimming Program to gauge their interest for being considered for a staff position. The Games Staff position(s) will be filled by current U.S. Paralympics Swimming employees and/or contractors who meet the criteria above.

The following group will evaluate the pool of coaches_staff for both-Assistant Coach(es) and Head Coach and other games staff positions for the 2023 Parapan American Games and will make the final nominations:

Director, U.S. Paralympics Swimming AAC Representative Sr Director, Internally Managed Sports

Recognizing that a staff is more than the skills brought by its individual members, coach <u>and games staff</u> nominations will take into consideration the mix of the full Team staff (experience, rapport with athletes and other staff, international event experience) as well as qualities beyond

technical skills and experience that will contribute to Team success.

4. Removal of Games Staff:

An individual who is nominated to an above-listed Games Staff position(s) by U.S. Paralympics Swimming may be removed as a nominee for any of the following reasons, as determined by U.S. Paralympics Swimming.

- 4.1. Voluntary withdrawal. Games Staff nominee must submit a written letter to the Director of U.S. Paralympics Swimming.
- 4.2. Injury or illness as certified by a physician (or medical staff) approved by U.S. Paralympics Swimming. If the individual refuses verification of his/her illness or injury by a physician (or medical staff) approved by the U.S. Paralympics Swimming, his/her injury will be assumed to be disabling and he/she may be removed.
- 4.3. Inability to perform the duties required.
- 4.4. Violation of the U.S. Paralympics Swimming's Code of Conduct (https://www.teamusa.org/usparaswimming/athlete-information).
- 4.5. No longer able to meet the required criteria in Section 2 at the time of the Games.

Once the Games Staff nomination(s) is accepted by the USOPC, the USOPC has jurisdiction over the Games Staff, at which time, in addition to any applicable U.S. Paralympics Swimming Code of Conduct, the USOPC's Games Forms apply. The USOPC's Games Forms are available as part of Games Registration prior to the respective Games.

5. Replacement of Games Staff:

In the event that the Nominated Games Staff member is unable to perform the duties of the position(s) for injury, illness, Code of Conduct violation or any other unforeseen circumstances that would result in the need to replace him/her, the replacement candidate must meet all of the applicable criteria listed in Section 2 above.

6. Group/committee that will make the final approval of the Games Staff position(s):

Chief, U.S. Paralympics Director, U.S. Paralympics AAC Representative

7. Conflict of Interest:

All individuals involved in the selection process (see Section 6) must comply with USOPC's conflict of interest policy, to include completing and submitting a disclosure form for review by USOPC's ethics committee prior to beginning the selection process.

An individual involved in the selection process who has an actual, possible, or perceived conflict of interest must disclose it to USOPC's ethics committee prior to the start of the selection process. The USOPC's ethics committee shall review the disclosure and determine the individual's level of involvement (e.g., whether he/she must recuse him or herself from the review process and/or voting).

Any recused individual shall be replaced in accordance with U.S. Paralympics Swimming selection committee appointment process.

8. Date of Nomination:

Nominations of Games Staff, including the names of any replacements, will be submitted to the USOPC on or before:

Medical: September 11, 2023

All Other Staff: October 2, 2023

9. Publicity/Distribution of Procedures:

The USOPC approved selection procedures (complete and unaltered) will be posted/published by U.S. Paralympics Swimming in the following location(s):

* If, for some reason, a sport does not have an elected USOPC AAC Representative, the NGB/PSO must designate an athlete from that sport to review and sign the Selection Procedures.
