

## Individual Training Sessions Minor Consent Form

Adult Participant: An Adult Participant is any adult (18 years of age or older) who is:

- 1. A member of USA Triathlon;
- 2. An employee or board member of USA Triathlon or a USA Triathlon Club;
- 3. Within the governance of disciplinary jurisdiction of USA Triathlon or a USA Triathlon Club;
- 4. Authorized, approved, or appointed by USA Triathlon or a USA Triathlon Club to have regular contact with or authority over minors.

If you are the Parent/Guardian of the Minor Athlete you do not need a consent form for yourself to have individual training sessions with your Minor Athlete.

**Individual Training Sessions**: All one-on-one, In-Program, individual training sessions must be observable and interruptible except if:

- An emergency exists; or
- A Dual Relationship exists; or
- The Close-in-Age Exception applies; or
- A Minor Athlete needs a Personal Care Assistant, and:
- the Minor Athlete's parent/guardian has provided written consent to USA Triathlon or USA
   Triathlon Club for the Adult Participant Personal Care Assistant to work with the Minor Athlete;
   and
- 2. the Adult Participant Personal Care Assistant has complied with the Education & Training Policy; and
- (3) the Adult Participant Personal Care Assistant has complied with USA Triathlon's policy.

Written consent from a Minor Athlete's parent/guardian is required for all transportation authorized or funded by USA Triathlon at least annually. A Minor Athlete or his/her/their parent or guardian can withdraw consent at any time.

Parents and legal guardians are encouraged to take the U.S. Center for SafeSport's education and training on child abuse prevention before providing consent for their Minor Athlete to train one-on-one with an Adult Participant.
