Executive Committee Update - Kristin Wattz

The Executive Committee met 6/20/25. Topics discussed included:

<u>Social Media Response</u>: Be cautious with comments. Refer observations and concerns over to Kristin and the Office of the Executive Director. If people have expressed legitimate questions on social media that should be addressed, let us know.

<u>US OPEN Update</u>: A press conference was held in Springfield, Missouri, on 6/10/25. Cindy Tilbury, Stewart Solomon, and Dan Whitley were in attendance.

Cindy announced that a free entry certificate for a junior division next year at the US OPEN will be given to gold medalists in Team Qualifying (gold) divisions at the Junior National Championships.

Office of the Executive Director: OED now consists of two individuals (Karen Grisz and Cheryl Kirk since Kristin has assumed the position of Board President. Looking for possible OED candidates (write to Kristin with thoughts; discuss qualifications). Another person doesn't have to be a Board member. It is considerable work, an unpaid position in support of racquetball.

<u>Due Process</u>: The Executive Committee, which is also the Grievance Committee, received a grievance that has moved into due process. We are executing the timeline in compliance with USA Racquetball's Grievance Procedure Policy.

Office of the Executive Director Report – Karen Grisz / Cheryl Kirk

<u>Committee Work</u> (calls/rosters/compliance docs): Communication has been sent to committee chairs asking them to distribute confidentiality and conflict of interest documents to be completed by themselves and their committee members.

Social Media Report: Mid-year analysis to take place relative to results and associated costs.

<u>USOPC Administrative Grants</u>: A call with the USOPC regarding 2025 and 2026 funding took place on June 23 with the application due on July 3. Annual grants assist NGBs with expenses related to SafeSport compliance, accounting, annual financial audits, 990 completion, etc.

<u>Junior Nationals Update</u>: Junior athletes numbering 170 will head to Minneapolis this week, Wednesday through Sunday, along with their coaches and family members. A committee met over the weekend to consider appeals once the draws were released.

<u>Pan American Games Announcement</u>: Regarding Lima 2027 Sport Programme inclusion, while Racquetball and other sports were not announced this week as being on the list of 36 sports for Lima 2027, we are hopeful that the official outcome will allow for inclusion.

Committee Updates

Finance - Sandy Rios

Sandy presented the financial reports through April 2025. We must and will treat fundraising and careful budgeting as priorities. The Board discussed both, including providing fundraising incentives to marketing interns and pro bono marketing/legal support.

Revenue/Fundraising -- Kristin Wattz

Stewart Solomon has agreed to head up fundraising initiatives. So far, 15% has been raised toward sending the Adult Team to TWG Chengdu in August. Stewart requests that as a Board each director fundraise at \$150/week by appealing to friends, family, and acquaintances.

U.S. Team Committee - Cheryl Kirk

An Elite Athlete Health Insurance slot was available after one U.S. Team athlete double qualified at the National Indoor Championships in May. A random generator tool was utilized to select one of the three U.S. Team athletes who expressed interest in receiving the insurance benefit. Robert Collins won the slot.

For The World Games 2025 (Chengdu, China), preparations (flights, accommodations, visas, uniforms) are in process for the official U.S. Delegation that consists of Coach Pablo Fajre with U.S. Team athletes Jake Bredenbeck and Naomi Ros.

The Athlete Development Program (ADP), founded and funded by Geoff Peters before he passed away in 2022, has ended due to all available funds being provided to qualified recipients. Athletes who participated in the program in 2024-2025 will be notified via email that the program has ceased.

Legislative Committee - Cheryl Kirk

The Legislative Committee brought recommendations on two of the four USOPC Audit remediations that are all due on or before July 25, 2025. Per the Bylaws, notifications were submitted to the Board 15 days prior to this meeting. The remaining two remediation recommendations will be brought to the Board at the 7/21/25 meeting.
