### **Executive Committee Update - Kristin Wattz**

The Executive Committee met Friday, July 18, 2025. Topics covered:

- Junior Working Group Restructure: Karen Grisz has become the lead.
- Pre-discussion on administrative fee proposal to bring to the Board (see Development Group, below)
- Erika Manilla suggested and with ExCom approval is gathering quotes to secure a Team USA-centric videographer/photographer for the early September tournament in Highlands Ranch, Colorado. Content on the U.S. Team will be valuable to the Marketing group 2025-26.
- In light of the recently published USOPC Athlete Safety Policy and USOPC NGB Safety Policy, the Executive Committee has asked the USAR Legislative Committee to conduct a review of the published documents and report back after analysis.

# Office of the Executive Director Report – Karen Grisz / Cheryl Kirk (P-3) Karen Grisz:

- As a cyclical initiative, Karen has connected with committee chairs asking them to submit updated rosters and gather completed Confidentiality and Conflict of Interest documents for themselves and their committee members.
- National Rules Committee met last week, forming recommendations for the Board's consideration.
- Jim Easterling is resigning as HOF Committee Chair. Replacement not identified as yet.
- National Events Advisory Group Recap status on the four 2026 tournaments; HS in STL; Phoenix National Indoor date may change to two weeks earlier. Golf tournament during our original dates. Club is available. Working with Group Housing to see if we can get rooms. Working to get the word out quickly.
- Social Media Report (P-3) Continuing with current campaign—Why do we Love Racquetball—and in two weeks will kick off a Meet the National Team campaign: videos (two-minute interviews) and photos. The campaign will begin with Naomi Ros and Jake Bredenbeck since they will be traveling to China in early August to compete in The World Games.

# **U.S. Junior Team Update**

- The 2025-2026 U.S. Junior Team was formed from National Junior Championships team qualifying results in Minneapolis, Minnesota, the last week of June. Thirty-five athletes (including two alternates) comprise the team. States represented are: California (10), Texas (10), Missouri (7), Illinois (2), Nevada (2), Florida (1), Minnesota (1), Nebraska, (1), and Tennessee (1).
- Handbooks/contracts nearly 100% complete, and a Zoom meeting was recently held with qualifying athletes and their families to provide details for the upcoming IRF World Racquetball Championship trip to Santo Domingo, Dominican Republic, December 5-13, 2025.

- Junior Coach Robbie Collins has contacted U.S. Team Committee Chair Larry Haemmerle to propose the coaching staff for World Juniors.
- The official invitation is about to be sent to the countries, and the commitment-to-participate deadline is August 15.

#### The World Games Chengdu Update

- Head Coach Pablo Fajre, athletes Jake Bredenbeck and Naomi Ros, and four accompanying travelers depart for China in fewer than three weeks.
- Preparations have been underway since directly after the National Indoor Championships in mid-May, and the Social Media Group has plans in place for coverage.

# **US OPEN Sponsorship Update - Cindy Tilbury**

Cindy delivered details to the Board encompassing a number of preparatory activities: press conference on June 10; facility visits; social media plan; website; hospitality plans; sponsor pitches. Tournament website, social media pages, and R2 site are up and running.

# Finance Committee - Sandy Rios (P-4)

May reports were sent as pre-reads to the Board. Positive cash flow achieved.

A meeting with the USA Racquetball accounting services provider took place on 7/18 to review and analyze accounting processes.

# **Development Advisory Group - Kristin Wattz (P-6)**

Stewart Solomon is contributing considerable work on present and future fundraising initiatives. Nearly \$5,000 has been raised to help cover costs for TWG Chengdu (see above).

Silent auction fundraising idea spurred by news of a possible donation of artwork.

Motion by Cheryl Kirk to approve the implementation of a policy to allocate 10% of all incoming donations—both restricted and unrestricted—to cover administrative and indirect costs of operating the organization. The policy will take effect September 1, 2025. Seconded by Sandy Rios

Discussion: Do we have a list of categories people can donate to? The Development Advisory Group is working on category development.

#### **Legislative Committee – Cheryl Kirk (P-5)**

Relative to the remaining remediations covered in the Report to the USA Racquetball Board of Directors, the USA Racquetball Legislative Committee met the 15-day notification requirement and subsequently brought the final Bylaws, policies, and/or related revisions to the Board of Directors for approval at this meeting. The deadline for all remaining submissions for the 2024 audit is July 25, 2025.
