TOPICS DISCUSSED:

Events:

- Discussed the registration status of upcoming national events:
 - National Golden Gloves
 - Next week in Philadelphia, PA
 - Top two in each Olympic weight class will qualify for Olympic Trials in December
 - National Jos/Summer Festival
 - Registration is picking up, with 700 boxers registered
 - We will release bracket quotas and finalize the check-in schedule in the coming days
 - Emphasized the importance of registering via the website, having all credentials and certifications up to date. We will not accept walk-ups. Registration will occur daily from 9:00 am – 11:00 am
 - The Junior Olympics will be for Bantam, Intermediate, Junior age categories
 - Outlined the sequence of events (opening ceremony, parade, etc.)
 - All other age categories are part of the Summer Festival
 - Women's Championship
 - 75 boxers registered, with more registration needed
 - Boxers will be matched up Monday, with boxers divided into two brackets, based on experience, by Tuesday night. The experienced bracket will count for ranking points but is not a pathway for advancement.
 - There will be no coaches space or sparring ring, as competition will take place throughout the event.
 - USAB will be inviting international officials and participants. Boxers can register using the following link: <https://forms.office.com/r/Bf0Sk96XPN>
 - Open workouts with Chad Wigle will be offered at the event
 - Last Chance Qualifier
 - Will take place in Pueblo, Colorado, September 9 – 16
 - Smaller event, with only 2 rings
 - More details will become available in the coming months

Operations:

- Unsanctioned Events
 - Discussed USAB's process on addressing unsanctioned events and the steps we take with the LBCs and state commissions to help put a stop to them.
 - Explained our disciplinary process for anyone participating in an unsanctioned event.
 - Encouraged LBCs to contact Andrew Banuet for assistance identifying and addressing unsanctioned events with their members.
- Matchtracker Update
 - 92.5% reporting rate, as of 5/2/2023
 - 46 LBCs have reported 100% of their bouts; 92.5% overall.
 - Explained the Matchtracker process and how to submit missing events

Membership:

- Membership is very busy, receiving a high volume of calls, documents, and emails to process

High Performance:

- High performance
 - Released their final Olympic Selection procedures.

 - LBCs are asked to review the new procedures to assist any boxers looking to join High Performance

- Coaching Education
 - There is a high demand to host coaching clinics in the Northwestern and Southeastern parts of the country, especially Florida. Encouraged LBCs to ask local clubs about hosting
 - In the coming months, Bronze coaches will be asked to wait 6 months before attending Silver coaching clinics.

- Grant
 - USA Boxing was awarded a grant. It's in partnership with a pharmacist group.
