Executive Committee Update - Kristin Wattz

- A newly created draft policy and rule change will be addressed in closed session after the regular meeting.
- Kristin and Cheryl will attend the USOPC NGB Assembly in SLC, last week of September.
- Kristin met with Kay Bartmann of RacquetX. They have committed to providing USAR a free booth, March 13-15, 2026, in Ft. Lauderdale. During the meeting, he asked if they could publicize USAR's Mixed Doubles Gold medal (Jake Bredenbeck and Naomi Ros) from The World Games in Chengdu, China.
- Expenditure approved not to exceed \$3,000 to engage a videographer/photographer at the Highlands Ranch tournament, September 4-7, to support promotional coverage of the U.S. Team for the rest of the season and additionally the Hall of Fame event. Erika Manilla covered plan details: Saturday all day, adult team members, junior members, amateurs, legends, Hall of Famers. The footage will be used for fundraising opportunities as well.
- Kristin reiterated her message of several weeks ago requesting Board member input to help identify future Board members as well as Office of the Executive Director potential candidates.

Office of the Executive Director Report – Karen Grisz (P-2) / Cheryl Kirk

- National Events Update most are set. National Indoor in February; High Schools in February (St. Louis); Intercollegiates in March (Minneapolis); Juniors in June.
- Karen is assuming leadership of the Junior Working Group; will begin to look at location several years out.
- Ankored is replacing Players Health, i.e. to provide electronic tracking of SafeSport, background checks, conflict of interest administration, etc.
- Jim Easterling resigned as Chair of the Hall of Fame/Awards Committee, and Todd Boss is assuming the position.
- Social Media Report was sent as a pre-read; no questions from the Board.

- U.S. Junior Team preparations are underway for the December 3-14 trip to Santo Domingo,
 Dominican Republic.

U.S. Team Committee - Cheryl Kirk

The U.S. Team Committee voted electronically to approve the recommendations of U.S. Junior Team Head Coach Robbie Collins to form the official roster of U.S. Junior Team Coaches and Staff for the IRF World Junior Championships in Santo Domingo, Dominican Republic, in December 2025. The Committee now makes the recommendation to the Board for ratification.
