RE: Preliminary Notice to the Athlete Selection Procedures for the Lima 2027 Pan American Games.

To provide information in a timely manner, USA Diving is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2027 Pan American Games (Games). This document is being written as a complement, and not a substitute to the 2027 Pan American Games Athlete Selection Procedures. Additional communication will be released by USA Diving once the Athlete Selection Procedures have been approved by the USOPC.

A. Anticipated Athlete Eligibility Criteria:

- Athletes must comply with all PanAm Aquatics (PAQ) eligibility requirements which will be posted here once available: https://www.panamsports.org/en/documents/?doc_category=games
- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all USA Diving, USADA, USOPC, WADA, and Panam Sports anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the [USOPC Background Check Policy](#) and [USOPC Athlete Safety Policy](#).

B. PAQ Qualification System Overview:

- The 2027 Pan American Games Qualification Systems Manual for diving has not been published by PAQ so the maximum Team size cannot be confirmed at this time. PAQ quotas are awarded by quota places to the National Olympic Committee (NOC).
- It is anticipated that the 2027 PanAm Aquatics Championships (dates TBD) will serve as the opportunity for federations to earn quota spots for the 2027 Pan American Games.

C. Anticipated Evaluation Events:

It is intended that athletes being considered for nomination to the 2027 Pan American Games will be evaluated on their performance at the below listed event.
