 - c. Brian will purchase 4 43-45" Smart TV's for to be used at the event and then included in the IL WSO equipment. The existing TVs we have are damaged. IL WSO will reimburse Brian for the cost.

All -

Tom has discussed with me his concerns having 2 platforms for the 2025ILST event.

 The number of entries is currently only 130 athletes. Registration closes soon and we do not expect a flood of additional entries.

For reference, 24ILST had 120 entries, with +35 on the wait list who did not get in. 23ILST had 110 entries and a +20 waitlist, 22ILST 91 entries

- With 2 platforms, the sessions will be very small. With one platform, we can keep sessions no larger than 15 but will one more session per day.
 - But we will need 1/2 as many volunteers.
- We are very very concerned that we will not get enough volunteers for 2 platforms. To date less than 5 have signed up for loading or ref.

Tom has already secured 4 people for the whole weekend who will be speakers or marshalls. We only need volunteers for weigh ins, ref, loaders.

 One sticking point - The additional Eleiko equipment we ordered to support 2 platforms. The 4 new barbells were delivered today. The bumpers, etc are in transit. This is a sunk cost.

Please review the possible schedules and respond to all your thoughts. If we can make a decision via email great, if not we MUST make a decision at our Sunday meeting.
