

Transportation Minor Consent Form

Adult Participant: An Adult Participant is any adult (18 years of age or older) who is:

- 1. A member of USA Triathlon:
- 2. An employee or board member of USA Triathlon or a USA Triathlon Club;
- 3. Within the governance of disciplinary jurisdiction of USA Triathlon or a USA Triathlon Club;
- 4. Authorized, approved, or appointed by USA Triathlon or a USA Triathlon Club to have regular contact with or authority over minors.

If you are the Parent/Guardian of the Minor Athlete, you do not need a consent form for yourself to transport your Minor Athlete.

An Adult Participant cannot transport a Minor Athlete one-on-one during In-Program travel except in the following circumstances:

- An exception exists. For more information on exceptions related to certain one-one-one
 interactions between a Minor Athlete and Adult Participant, please see the <u>USA Triathlon</u>
 <u>SafeSport Policy Handbook</u>.
- a. An emergency exists;
- b. A Dual Relationship exists;
- c. The Close-in-Age Exception applies; or
- d. A Minor Athlete needs a Personal Care Assistant (Note: All requirements under this exception must be met.)
- 2. The Adult Participant has advanced, written consent to transport the Minor Athlete one-one, obtained at least annually from the Minor Athlete's parent or guardian.
- 3. The Adult Participant is accompanied by another Adult Participant or at least two minors who are at least 8 years of age.

Written consent from a Minor Athlete's parent/guardian is required for all transportation authorized or funded by USA Triathlon at least annually. A Minor Athlete or his/her/their parent or guardian can withdraw consent at any time.

Parents and legal guardians are encouraged to take the U.S. Center for SafeSport's education and training on child abuse prevention before providing consent for their Minor Athlete to travel one-on-one with an Adult Participant.
