Adult Participant: An Adult Participant is any adult (18 years of age or older) who is:

1. A member of USA Triathlon;
2. An employee or board member of USA Triathlon or a USA Triathlon Club;
3. Within the governance of disciplinary jurisdiction of USA Triathlon or a USA Triathlon Club;
4. Authorized, approved, or appointed by USA Triathlon or a USA Triathlon Club to have regular contact with or authority over minors.

If you are the Parent/Guardian of the Minor Athlete, you do not need a consent form for yourself to transport your Minor Athlete.

An Adult Participant cannot transport a Minor Athlete one-on-one during In-Program travel except in the following circumstances:

1. An exception exists. For more information on exceptions related to certain one-one-one interactions between a Minor Athlete and Adult Participant, please see the [USA Triathlon SafeSport Policy Handbook](#).
 - a. An emergency exists;
 - b. A Dual Relationship exists;
 - c. The Close-in-Age Exception applies; or
 - d. A Minor Athlete needs a Personal Care Assistant (Note: All requirements under this exception must be met.)
2. The Adult Participant has advanced, written consent to transport the Minor Athlete one-one, obtained at least annually from the Minor Athlete's parent or guardian.
3. The Adult Participant is accompanied by another Adult Participant or at least two minors who are at least 8 years of age.

Written consent from a Minor Athlete's parent/guardian is required for all transportation authorized or funded by USA Triathlon at least annually. A Minor Athlete or his/her/their parent or guardian can withdraw consent at any time.
