#### RULES

Divisions can be cancelled or combined at the discretion of the tournament committee. No prizes will be awarded for splits, default losses or no-appear, or dumps. The rules of ITTF and USATT policies will govern the tournament. All decisions of the tournament referee are final.

#### **FORMAT:GRR**

Format: Morning RR will determine the Championship Division, A, B & C divisions. From the Divisional groups the top 2 players in each group will advance into the Single Elimination (SE) rounds.

#### **DRESS CODE**

White shirts or shorts/skirts during play are not allowed. All USATT and ITTF rules and regulations will be followed.

### **EOUIPMENT**

The tournament will feature the following 25mm top ITTF approved tables:

- Tournament ball: White Yinhe 3 Star H40+ ABS balls.
- · Flooring is Purple rubberized mat.

#### **MEMBERSHIP**

Proof of USATT membership is required. Membership may be purchased along with tournament entry form. Adult basic membership \$25/year, Pro membership \$75/year. Players who don't want to purchase a full membership may purchase a tournament pass for \$50.

\*\*\* You may purchase a tournament pass even if you were previously a USATT member or have never purchased a tournament pass.

#### **MATCH CHECK IN**

PLAYERS SHOULD CHECK IN AT LEAST 30 MINUTES BEFORE THEIR FIRST MATCH and should be ready to play each match at least 15 minutes prior the scheduled starting time for each event. PLAYERS WHO ARE NOT PRESENT AT THE TIME THEY ARE SCHEDULED TO PLAY A MATCH, WILL BE DEEMED TO HAVE DEFAULTED THAT MATCH AND ENTRY FEES.

### PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain Positions of Authority must complete Safe Sport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). #### **USATT COACHING POLICY**

All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents /legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing criminal background screen every two years.

### ADULT PARTICIPANTS REQUIRING SAFE SPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, <u>ALL Adult Participants</u> (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

# CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

#### **MANDATORY REPORTING**

There are certain circumstances where reporting a potential Safe Sport violation is mandatory. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. Child abuse must be immediately reported to local law enforcement.
