Equipment: Joola Tables, Nets, Barriers, and **Joola Prime 40+** 3-star Balls. The floor will be a cushioned vinyl mat over wood flooring.

Rules: Players must be members of the USATT. The Laws of Table Tennis as published by the ITTF, and all USATT regulations apply. The USATT dress code will be observed. All matches will be best of 5 games to 11 points, except Open Singles quarter through to the final, which will be best of 7 games.

Policies: Players may not enter two events with identical start times. The tournament committee reserves the right to restrict the number of players in any event. Players are restricted to a maximum of four events per day. Events with insufficient entries may be canceled, and fees refunded. Unrated players will not be allowed to advance out of groups in rating events. They will, however, advance from Open events and Singles and Doubles age group events.

Payment: Payments must be received prior to the start of the tournament either online or by check and will not be accepted at the tournament. Payment for online registration must be made within three days or your entry may be removed to free up a slot for another player.

Age Events: Players in Junior Events must be the correct age for their event as of **08/9/2025**.  
Players in Senior Events must be the correct age for their event as of **12/31/2025**.

Entry Deadline: Mail in entries must be postmarked by Friday, **July 25, 2025**.  
Online entry available through Friday, **August 1, 2025**.  
**10% Early Bird Pricing available if entry received and paid by 7/12/2025**

Registration: Players must register with tournament officials at least 30 minutes before their first match and be ready to play each match 10 minutes before the scheduled starting time.

Withdrawal: Any player who wishes to withdraw from the event must do so by **July 25, 2025**. There will be no refunds after this date.

Ratings: Your rating as of **June 28<sup>th</sup>** will be used for event qualifying. Seedings will be based on the most current rating available.

1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.

4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
