# II. Chair Report

On May 1, S. McNally reached out to me about the conflict of interest forms. AAC at this point in time had not received the COI forms for signing yet.

Two concerns have been brought to attention.

- 1) The terminology regarding participating in grand prix. What does that really mean? Can it be stated more clearly based on what USATKD wants the definition to reflect.
  - a) DT reached out to Barbara Brand about participation. It's listed here and that's it. CF thinks we should recommend putting it in future event packets.
- 2) The price of competitions, which is potentially drawing people away from USATKD competitions and driving them to find other, less expensive competitions to attend
  - a) This is an ongoing issue. Charging premium prices but not provided premium events.
  - b) CL has heard similar complaints multiple events, families with multiple kids. Change in quality does not match the change in price. The more alarming thing that has been said if USATKD does seem to think they are doing a good job, that's an issue. The quality of the event should go up.

c) DT: it's not just the competitions, it's everything they are doing. The camps are outrageously priced for what they are offering. They are not willing to pay the coaches. And then they charge a premium fee. Have heard comments about the academic program. What's the point of charging \$80 for this certificate?
