



Lodging Minor Consent Form

If you are staying onsite or offsite to access a USA Triathlon program or activity of any kind, the lodging consent form is required.

Adult Participant: An Adult Participant is any adult (18 years of age or older) who is:

1. A member of USA Triathlon;
2. An employee or board member of USA Triathlon or a USA Triathlon Club;
3. Within the governance of disciplinary jurisdiction of USA Triathlon or a USA Triathlon Club;
4. Authorized, approved, or appointed by USA Triathlon or a USA Triathlon Club to have regular contact with or authority over minors.

If you are the Parent/Guardian of the Minor Athlete, you do not need a consent form for yourself to lodge with your Minor Athlete.

Lodging: All In-Program Contact at a hotel or lodging site between an Adult Participant and a Minor Athlete must be observable and interruptible, and an Adult Participant cannot share a hotel room or otherwise sleep in the same room with a Minor Athlete(s), except if:

- a) An emergency exists; or
- b) A Dual Relationship exists, and the Minor Athlete's parent/guardian has provided USA Triathlon or USA Triathlon Clubs or with advance, written consent for the lodging arrangement; or
- c) The Close-in-Age Exception applies, and the Minor Athlete's parent/guardian has provided USA Triathlon or USA Triathlon Clubs with advance, written consent for the lodging arrangement; or
- d) A Minor Athlete needs a Personal Care Assistant, and:
 - (1) the Minor Athlete's parent/guardian has provided written consent to USA Triathlon or USA Triathlon Clubs for the Adult Participant Personal Care Assistant to work with the Minor Athlete, and the Minor Athlete's parent/guardian has provided USA Triathlon or USA Triathlon Clubs with advance, written consent for the lodging arrangement; and
 - (2) the Adult Participant Personal Care Assistant has complied with the Education & Training Policy; and
 - (3) the Adult Participant Personal Care Assistant has complied with USA Triathlon's policy.

Written consent from a Minor Athlete's parent/guardian is required for all transportation authorized or funded by USA Triathlon at least annually. A Minor Athlete or his/her/their parent or guardian can withdraw consent at any time.

Additional Information

Monitoring or Room Checks During In-Program Travel

If USA Triathlon, USA Triathlon Clubs or team performs room checks during In- Program lodging, the one-on-one interaction policy must be followed and at least two adults must be present for the room checks.

Additional Requirements for Lodging Authorized or Funded by the Organization

- Adult Participants traveling with USA Triathlon or USA Triathlon Clubs must agree to and sign USA Triathlon's consent form at least annually.
- Adult Participants that travel overnight with Minor Athlete(s) are assumed to have Authority over Minor Athlete(s) and thus must comply with the Center's Education & Training Policy.
