ELIGIBILITY: Sanctioned. This tournament is open to all players rated U2150, U1400, U1300, U800, U1150, U1050, U1000, U900, U700. Unrated players can participate in the RR stage but cannot advance to the SE stage.

DEFAULT POLICY: All entries must include full payment to be included in the draw(s). All ITTF/USATT regulations apply.

The tournament committee reserves the right to cancel any event if there are insufficient entries.

DRESS CODE: Must abide by the USATT dress code: Shorts, sweatpants, and leggings are allowed. Sneakers ONLY. No white shirts.

I understand USATT's Safe Sport Policy including the organization Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that under USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.

For USATT's MAAP Policy, "regular contact with" is defined as: "ongoing interactions during 12 months wherein an Adult Participant in a role of direct and active engagement with any Minor Athlete(s)"; and "authority over" is defined as: "when one person's position over another person is such that, based on the totality of the circumstances, they have the power or right to direct, control, give orders to, or make decisions for that person. "
