## Reporting

All players need to report in the call area 20 minutes before the match.

#### **Draws**

Draws will be made at least one (1) day before each competition.



#### Accreditation

All coaches will be required to have an accreditation to access the Field of Play. To be eligible for accreditation all coaches need to be fully Safe Sport Compliant and have a current criminal background check.
