



Board of Directors Meeting Minutes November 5, 2025

Meeting Called to Order: Tyson Lee, Board Chairperson called the meeting to order at 6:04 pm MST. Lee stated that in accordance with USOPC compliance at the beginning of each meeting, board members need to review the agenda and disclose any perceived conflicts of interest. The board reviewed the agenda and there were no perceived conflicts of interest.

Roll Call: Stacy Arredondo, Program & Project Specialist, conducted roll call.

Board Members Present: Colin Brady, Sa'Rai Brown-El, Hector Colon, Christy Halbert, Meg Lassarat, Tyson Lee, Lauren Migliacci, Danielle Perkins, Elise Seignolle, Darryl Smith, Stacia Suttles, Absent: Angelica Colantuoni, Dean Fay, Alex Love, and Chris Trombetta. A quorum was reached.

Staff present: Mike McAtee, Executive Director; Lisa Peterson, Finance Director; Lynette Smith, Membership Director; Mike Campbell, Events & Boxing Operations Manager; and Stacy Arredondo, Project & Program Specialist.

Proposed Fee Increase for 2026: Lee initiated a structured discussion, allowing members to voice their opinions on the proposed fee increases. The discussion included that fees had not been raised since 2019 or 2013 in some categories; the understanding that many boxers don't have a lot of money but \$5-\$10 within six years is necessary to keep up with inflation; searching fundraising and grant opportunities for the future; typo in memo for 8-10 year olds (\$55 + \$5 = \$60); the timing of the increase due to 2026 registration starting in November and the 2026 budget preparation; funding necessary for grassroots support and the pipeline for Youth and Junior boxers; insurance costs; fees in line with comparisons to other National Governing Bodies (NGB) sports; questions about the tiered approach with younger boxers fees less; freezing LBC additional membership fees for 2026; and how a small amount to the members make a big difference for the organization.

McAtee assured the board that the Communications Department would work on messaging to inform the members and stated that the increase wouldn't go into effect until November 13, 2025 to give those an opportunity to register if they'd like to save the increase. He also stated that the Audit Committee would work on a future plan for incremental increases to keep up with inflation.

A MOTION was made (Lassarat) and seconded (Seignolle) to approve the proposed fee increases (listed below) which includes the memo typo correction (Resolution 1). MOTION PASSED UNANIMOUSLY.

Brady discussed his experiences in England, including training with the Empire Fighting Chance program and attending a parliamentary meeting that focused on boxing. He highlighted the importance of working with partners to secure funding and improve financial sustainability for boxing programs.

Creating a fundraising initiative to support future increases was further discussed.

Lee thanked the staff for their work and the board for their support of grassroots.

Adjournment: At 6:42 MST, a MOTION was made (Colon) and seconded (Smith) to adjourn the meeting. MOTION PASSED.
