### 1. Call to Order

- **Chair:** Khoa Nguyen
- **Conflict of Interest Check:** Chair Khoa Nguyen called for any actual, anticipated, or perceived conflicts of interest. None were identified.

### 2. Approval of Minutes from January 9, 2024

- A motion to approve the minutes of the meeting held on January 9, 2024, was properly presented and seconded.
- **Resolution:** The committee unanimously resolved to approve the January 9, 2024, meeting minutes, which are now formally entered into the record.

### 3. Meeting Discussion

- **World Championships Report:**
  - Coaches provided a report on the team's performance at the Busan World Championships.
  - An incident was discussed in which the team was disqualified against Kazakhstan due to a failed racket control test by one of the players.
  - **Proposals:**
    - Add a racket control requirement to the Player's Code of Conduct, ensuring players are responsible for passing racket tests.
    - Send a warning letter to the player involved, along with the official letter from the ITTF.
- **Mixed Doubles Format and Selection at the US Olympic Trials:**
  - The committee discussed and proposed a specific format for selecting mixed doubles teams at the US Olympic Trials.
- **North American Championships:**
  - Freddy joined the meeting to provide an update on WR points for the North American Championships.
  - Canada provided feedback suggesting that the North American Championships be held in 2025.

### 4. Motion and Approval

- **Racket Control Proposal:**
  - **Motion:** A motion was presented to approve the HPC's proposal to address the racket control issue by incorporating it into the Player's Code of Conduct.
  - **Resolution:** The committee unanimously approved the motion regarding racket control.
- **Mixed Doubles Selection Format:**
  - **Motion:** A motion was presented to approve the HPC's proposal for the mixed doubles selection format at the US Olympic Trials.
  - **Resolution:** The committee unanimously approved the motion for the mixed doubles selection procedure.
