USA DIVING RULE PROPOSAL SUBMISSION PROCEDURE AND PROCESS

(May, 2021)

Rule Proposals will be collected throughout the year and reviewed quarterly (Jan 1-March 31, April 1-June 30, July 1-Sept 30, Oct 1-Dec 31). Assessment of each Rule Proposal submitted in a given quarter will be finalized within 45 days of the end of each Rules Submission Quarter.

The following outlines the process as to how the rule proposal will be vetted:

The Working Rules Committee of the Committee for Competitive Excellence (CCE) will receive the rule submission at any time within the active quarter.

Upon review the working rules group of the CCE will forward said proposal to the entire CCE as well as the Coaches Advisory Committee (CAC) and the Athletes Advisory Committee (AAC) for review and discussion. These committees will review and advise the CCE of their approval, proposed modifications, or denial within 15 business days of receipt of the proposal.

Once the CCE receives all recommendations from those groups, the CCE will then finalize the proposed rule and submit it to the General Membership of USA Diving for an open forum question and ask period, lasting at least 10 and up to 30 business days.

After that open discussion period, the CCE will then forward the final, approved rule proposal to the Board of Directors for their approval or denial of the proposed rule.
