## OPENING REMARKS

### Olympic Update

- World Boxing will go to the exec board of IOC March 15. At that time, we will turn in our application to receive provision recognition. The exec board will vote on whether WB will be the IF for Olympic boxing.
- Panamerican Confederation is 1<sup>st</sup> confed with World Boxing
- Mar 20 – 22, IOC Present election. If approved on March 15<sup>th</sup>, they will vote to determine if boxing is added back to the Olympic program. There will be 7 men and women's weight classes in 2028.

## EVENTS:

### National Events:

#### International Open – Pueblo, CO | Apr 13 – Apr 19, 2025

- Citizenship is not required. Exclusive for higher tier members. Inquires from all over, Fiji, ghans, New Zealand, Mexico, Canada, amongst others.
- International boxers are welcome at all national event, except natl championships & JO
- Two rings only.

#### National JOs – Summer Festival – Las Vegas, NV | June 14 – 21, 2025

- Venue: The Las Vegas Convention Center
- Host Hotel: Westgate Las Vegas Resort & Casino
- We will look to have five rings, with an anticipated 1,200 boxers
- Asked LBCs to begin planning local JO tournaments.

#### Unannounced Event – Tulsa, OK

- Agreements are being finalized. More information to come.

## OPERATIONS:

### OIC Assignment Changes

- Changes were made to Webpoint requiring the COO to assign the OIC for a sanction. Sanction holders can no longer enter an OIC at the time of application.
