## **AGENDA ITEMS: STATE CHAMPIONSHIPS**

### Rotating the WSO championship location

(#5 From Agenda distributed by email)

Several pro's and con's were spoken about, such as how to decide how's eligible, and logistics from a participation standpoint.

### **Voting will be yes/no on the following provisions:**

1. Must have a member on the board
2. Participation – top 3 teams will be selected based on number of lifters for event.

Once this is established, discussion will then proceed to see if there's interest/availability for any of them to hold event the following year

### **Vote – Yes/No w/recommended amount \$1k/\$1500**

Financial gain for event holder – Small fee for organizing and hosting the event itself

### Eligibility for Funding

### **Vote will be yes/no on the following provisions:**

1. In order to be eligible for funding from the WSO, athlete MUST participate in the State Championship

### Funding Usage from WSO

(#4 From Agenda Distributed by email)

Multiple ideas and options were discussed about how to distribute funds amongst the athletes. Including, paying entry fees, solely performance based, hardship cases.

**Vote will be yes/no based on the following option for 1<sup>st</sup> year (2022), with additional options to be added in the future after seeing what happens this year.**

1. 50% of funds for participation/50% of funds for high performance initiatives
2. Nationals only this year, with potential for AOF added in next year
3. Performance bonuses to be reassessed next year
