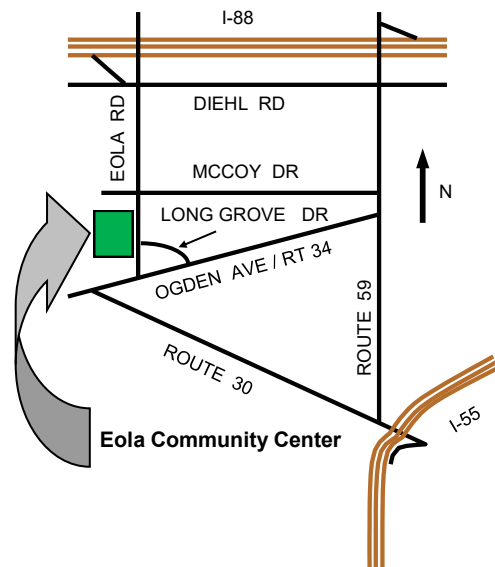

Rules and Policies

- ◆ Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event is cancelled the fees for this event will be refunded.
- ◆ USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball (white). No white shirts, shorts and skirts allowed.
- ◆ All USATT regulations apply. Only USATT approved equipment will be used: 12 blue Donic Waldner Classic 25 tables with blue Donic Stress nets and white 3-star JOOLA Prime ABS 40+ plastic balls.
- ◆ All matches are best 3 out of 5 games to 11 points.
- ◆ For seeding the events ratings from August 29th will be used.
- ◆ No prizes will be awarded for splits, defaults and no-shows. Default time is event start time.
- ◆ Players must register at the desk no later than 30 minutes before the starting time of their event.
- ◆ Gym will be open for practice from 8:00 am. Pre-match warm-up will be limited to 2 minutes.
- ◆ All events will be round robin in groups of 8 players.
- ◆ Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prizes or trophies except for top division (1st – 8th seed).
- ◆ Withdrawals up through August 31st, 2025 will be eligible for full refunds. After that date refunds will only be issued if there is someone on the waiting list who fills vacated spot.
- ◆ Any image, photographic or otherwise, taken of the tournament play or within the official venue is essentially the property of FVTTC (Fox Valley Table Tennis Club) and USATT. Entrants agree to allow their picture, voice and likeness to be reproduced in connection with FVTTC or USATT by way of any medium.

From the East: Take I-88 west until Route 59 exit. At the light turn left. USATT TOURNAMENT PARTICIPANT WAIVER

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT

DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in this table tennis tournament. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.
