EVENTS

National Events

- 2024 National Championships
 - 45 boxers are still on the waitlist. However, the event registration was closed a few weeks ago to help moderate a successful tournament. We are working on this list daily.
 - 950 boxers is the goal for the event. We will work on wait lists when we get to that number.
 - USA Boxing has no more rooms available for Nationals in December. Attendees are responsible for securing their own lodging. For those who cannot be allowed into the tournament, we will have options for non-competition boxers to spar.
 - We will send a final list in the coming days.
 - We had a last minute cancellation for admin staff. Offered LBCs to send a qualified official to work this role, where they will learn the Xempower system, as well as help with other administrative tasks throughout the event. Please contact mcampbell@usaboxing.org for more information.
 - Will implement self-check in for late arrivals to help streamline administration of the event and prevent unnecessary drops outs. Emails surrounding that have been sent.
 - Boxers and coaches who arrive early on Friday and Saturday will receive tickets to Claressa Shield's Biopic, *A Fire Inside*. Tickets are first come, first served. More information will be available at check-in.
