


Volunteer Spotlight

Shawn Reese - RJ Chairperson

Shawn Reese has been a staple within the USA Boxing family ever since he was a youth. Hailing from a family of Olympic-style boxing officials, Reese has been a prevalent figure in the world of officiating, both within the United States and internationally. After serving as a referee in the Paris 2024 Olympics, he has since turned his attention to assisting World Boxing in gaining recognition as an international federation by the International Olympic Committee. Reese has consistently raised the standard by which officials within the United States and across the globe are measured and he has been instrumental in providing educational opportunities for his fellow officials. A native of Tennessee, Reese has engrained his blue-collar work ethic into the officiating side of Olympic-style boxing, providing a framework for others to imitate to progress within the sport. He has now retired as a firefighter and currently dedicates his free time to evolving our sport and growing opportunity for officials and boxers.

In addition to his efforts within the sport, Reese currently serves as the chair of the USA Boxing R&J Committee, where he has revamped the officials' certification process, paving a way for officials to move from pathway to Level 3. Within that role, he has also created a rankings system and developed a survey for the Official in Charge position.

We thank Shawn for all his hard work as his volunteer hours almost equal full time employment with USA Boxing!

Disciplinary Process

The Judicial Review Panel is comprised of five members of the USAB staff from different departments. Once a complaint has been received and validated, the process may be to issue an Administrative Hold of Temporary Measures against the membership of the accused pending the investigation.

The accused is given the opportunity for their statement regarding the allegations. When possible, the Panel meets up to twice per week and discusses at length, the issue and any disciplinary action(s) against the person(s) who committed the violation(s).

After a decision has been rendered, a letter of "Disciplinary Action" is emailed out with a requested response time for the acceptance or rejection of action. If a rejection is received, the matter is then presented to the Judicial Committee for review and/or hearing. Both the Administrative Hold notice and the Disciplinary Letter are copied to the accused's home LBC and other parties on a need to know basis only.

All cases are strictly confidential at all times and never shared with a 3rd party. Below is a recap of the reported cases the Panel has worked on in the 3rd and 4th Quarters of 2024.

USA Boxing is excited to announce that the six recipients of its **Gold Level pilot coaching certification**, which took place January 12-18, at the USOPC Training Center in Colorado Springs, CO scored 100% on the test.

Edward Fonteneaux, Danilo Garcia, Gilberto Garza, Julia Gschwind, Jonathan Pramas

and Eric Zimmerman are the six coaches who took the course, which was **led by the USA Boxing High Performance team**, including USA Boxing National Head Coach, Billy Walsh, and National Resident Coach, TJ Nolan. Additionally, USA Boxing Assistant High Performance Director and Head Strength and Conditioning Coach, Jose Polanco, National Team Athletic Trainer, Maddie Kalke, and National Team Dietitian, Taylor Maggio, led training within their respective fields throughout the course.

USA Boxing will hold three Gold level certification clinics in 2025 that will each be one week in length. The cost of the clinic is \$1,000/person, which includes housing and meals at the Olympic and Paralympic Training Center for the week. Flights to Colorado Springs are not included and will be the responsibility of the registered participants/coaches.

The application for the Gold Certification held in March will remain open until February 4, at 5:00 pm MT. Payment for registration will be required if your application is approved.

To be eligible to take the Gold Level certification course, coaches must complete the following prerequisites:

- USA Boxing Silver level Certification
- USA Boxing Nutrition Certification
- USA Boxing Strength and Conditioning Certification

NOTICE OF SAFESPORT MAAPS POLICY ON ELECTRONIC COMMUNICATIONS

For the safety of our boxers, remember that all electronic communication must be *Open and Transparent*, meaning that:

- Communication between an Adult Participant and a Minor Athlete must include a parent/guardian, another adult family member of the Minor Athlete, or another Adult Participant.
- This includes all communication started by a Minor Athlete.
- Only electronic platforms that can be Open and Transparent should be used.
- All team communication or communications with multiple Minor Athletes from an Adult Participant must copy or include another Adult Participant, or all the Minor Athletes' parents/guardians.

2024 World Boxing U19 Championships & Congress Recap

The 2024 World Boxing U19 Championships, held in Pueblo, CO, concluded on November 2, 2024. **Team USA sent 11 boxers, six male and five females to the inaugural World Boxing U19 Championships and closed the week with a slew of dominating performances.**

Team USA earned eight medals, including three gold for **Lorenzo Patricio (50kg)**, **Joseph Awinongya (75kg)**, and **Elijah Lugo (80kg)**. These three boxers etched their name in the history books, earning the first World Boxing gold medals at a world championship for the international federation. In addition to the gold medals, **Emmanuel Chance (55kg)** and **Rishon Sims (90kg)** earned silver, while **Shamiracle Hardaway (60kg)**, **Nevaeh Williams (65kg)**, and **Laila Zakirova (51kg)** all secured bronze medals on the women's side of competition.

USA Boxing was led at the event by National Development coach Chad Wigle (Colorado Springs, CO). Assisting Wigle were assistant coaches Danilo Garcia (Oakland, CA), Edward Fonteneaux (Fayetteville, NC) and Blanca Gutierrez (Pacifica, CA).

Following the U19 Championships, USA Boxing hosted the second annual World Boxing Congress on November 3, 2024, in Colorado Springs, CO. In this congress, World Boxing approved applications from the National Federations of Uzbekistan, Kazakhstan, Guatemala and Laos.



