I was a public relations professional in health care and nonprofit organizations prior to becoming a university faculty member in communication. Currently retired, I served as department chair and held several university leadership appointments during my nearly 30 years at Otterbein University as a senior instructor. I hold a bachelor's degree in journalism from The Ohio State University, and a master of arts in management and supervision from Central Michigan University.

Leadership or Administrative Experience in Artistic Swimming

Within the sport of artistic swimming, I have held many leadership positions on a local, zone and national level. In the Ohio Association I served as technical and officials chair previously. I served as North Zone officials and administrative chair. Nationally, I served the Board of Directors as a vice president of competitive operations and then as president from 2020–2024. Currently I am on the board as immediate past president (non-voting) and am serving as secretary. In addition, beginning in 2005 I served as national team manager for multiple teams including juniors, national team two and the senior team including as assistant manager for the 2008 Olympic team. My service to the national team continued for many years as needs arose.

Artistic Swimming Background / Experience

I became involved in the sport of artistic swimming as a masters athlete in 1981. Over the years as my children became involved in the sport, I became a coach and ultimately ended up head coach of the Columbus Coralinas. I retired from that position and the club transitioned to the Ohio Coralinas, but I remained involved in association and zone leadership positions as well as being a national judge. I continue to offer my assistance to the board of directors as a volunteer; attend national, zone, regional and location competitions as an official; and am currently filling a one-year unexpired term on the USAAS Foundation board of trustees.

Why would you be a strong candidate for a leadership role on the USAAS Board of Directors?

The foundation plays an essential role in our sport as we fund programs such as national teams, education and membership growth strategies. We have the potential to grow revenue for USA Artistic Swimming through the growth of the foundation. The sport grows when funding grows and vice versa. With growth of our core funds we can grow the amount that can then be given back to the sport. Judy was my mentor when I served as USAAS board president. I want to help identify the individuals who are as committed to the well-being of artistic swimming as she was. She had a vision and I hope I may continue to help that vision materialize in our efforts to fund the future of the sport.
