

COMPLAINT FORM

GRIEVANCE AGAINST US SPEEDSKATING

This Complaint Form (the "Form") for a Grievance Against US Speedskating ("<u>USS</u>") **must be filed by a member of USS** who is directly affected by the alleged violation, or by a parent or legal guardian on behalf of USS members who are under 18 years of age (the "<u>Claimant</u>"), alleging **that USS has violated one (1) or more of the following**:

- (i) USS's Bylaws, rules, policies and/or procedures (including allegations that USS has violated the Claimant's opportunity to participate in a protected competition);
- (ii) the Bylaws of the United States Olympic Committee ("USOC"); and/or
- (iii) the Ted Stevens Olympic and Amateur Sports Act (36 U.S.C. § 220501 et. seq.) (the "Sports Act").

| A Grievance Against USS (the " <u>Grievance</u> ") that is not filed in accordance with Section 14.8 of the USS Bylaws shall render the filing defective, and the Grievance shall not be considered to have been properly filed. The Grievance shall be filed with the Executive Director of USS and shall also be accompanied by a non-refundable filing fee of \$100.00 made payable to USS. | Grievance must be filed within 120 days of the date that the Complainant knows, or reasonably should have known, of the facts giving rise to the Grievance Against US Speedskating, except in the case of allegations of a denial of an opportunity to participate, in which case the Complainant must file a Grievance Against US Speedskating within 180 days of the date of the alleged denial. |

<u>Please Note</u>: As set forth in Section 14.8(B) of the USS Bylaws, any USS member alleging the denial or threatened denial of the right of an opportunity to participate in a protected competition has the right to either (i) file a Grievance in accordance with the procedures set forth herein and in Article 14 of the USS Bylaws, or (ii) avail himself or herself of the rights and remedies available pursuant to Section 9 of the USOC Bylaws. Any questions concerning the rights and remedies available pursuant to Section 9 of the USOC Bylaws may be directed to the USOC Athlete Ombudsman at 888.ATHLETE (888.284.5383).
