SECTION 1: OVERVIEW

These procedures outline the pathway for selection to the 2026 Para Pan American Championships as well as the 2026 World Para Taekwondo Championships, for K44 Kyorugi.

The maximum team size is estimated to be 10 athletes (5 male/5 female). Alternates will be registered for these tournaments if allowed by the Pan American Taekwondo Union and World Taekwondo.

SECTION 2: ATHLETE REQUIREMENTS

1. Nationality/Passports Requirements:

- Have a valid United States passport at the time of the 2026 U.S. National Team Trials that does not expire for six months after the conclusion 2026 World Para Taekwondo Championships.

2. Minimum World Taekwondo (WT) Requirements:

- Must be a citizen of the United States of America.
- Must hold a valid 2026 WT Global Athlete License
- Holder of a Para Taekwondo Dan certificate issued by the WT (Article 4.1.3)
- Holder of a 8 Geup to 1 Geup certificate, issued by the WT (Article 4.1.4)
- Athlete must compete in the senior division, 16 years or older in the year of the pertinent competition World Taekwondo (Article 4.1.6)
- Must comply with any IPC and WT classification guidelines for each sport class

3. National Governing Body (NGB) Requirements:

- Comply with the USATKD Athlete Agreement
- Comply with the [USATKD Code of Ethics](#).
- Comply with the [USATKD SafeSport Policy](#).
- Athlete must be a USATKD member in good standing.
- Athlete does not have an active suspension from the U.S. Center for SafeSport that would make the Athlete ineligible to participate as a member of the 2026 National Team.
- Athlete does not have an active sanction for an anti-doping rule/policy violation that would make the Athlete ineligible to participate as a member of the 2026 National Team.

SECTION 3: OTHER MINIMUM REQUIREMENTS TO BE ELIGIBLE FOR THE TEAM

- Meet the U.S. Center for SafeSport’s education and training requirements in accordance with the [USOPC Athlete Safety Policy](#) if you will be 18 or older on the day after the Closing Ceremony.
- Agree to be bound by and adhere to all WT, PATU, USATKD, WADA, USADA and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-Competition Testing and an agreement to be bound to the results management authority of WT, PATU, USATKD, WADA, USADA, or other Anti-Doping Organization as applicable.
- Meet all health and safety protocols, to include vaccine requirements and/or testing requirements set forth by the government, local laws, USOPC, WT, PATU, USATKD, and/or the Local Organizing Committee.

SECTION 5: SELECTION PROCESS

The 2026 Pan American Championship and World Para Taekwondo Championship Team will be determined by the winners of the K44 Para Taekwondo division at the 2026 U.S. National Team Trials, January 30 – February 1, 2026 in Tulsa, Oklahoma. This team will represent Team USA at the upcoming 2026 Pan American Championships (May 9 – 10, Rio de Janeiro, Brazil) and the World Para Taekwondo Championships (Date and Location TBD).

The maximum team size can be 10 athletes (5 male/5 female). The 2026 Pan American Championships and World Taekwondo Para Championships will use the above divisions. If a MNA is allowed to register multiple athletes in a division, the runner-up in any division will be registered for either tournament.

5.2 EVALUATION EVENT QUALIFICATION PATHWAY:

- Registration and Team Trials information will be posted online at <https://www.usatkd.org/2026-U-S-NATIONAL-TAEKWONDO-TEAM-TRIALS>. This is an open Team Trials.
- Athletes interested in participating in the open Team Trials will need to contact Eric Wininger, Director of National Teams at ewininger@usatkd.org, no later than January 8, 2026 at 11 a.m. EST to be registered for the event.
- Athletes will be added to the [Sport80](#) registration system.
- All athletes hoping to represent Team USA in 2026 Para Taekwondo K44 Events should arrange for appropriate time off from school, work or other obligations to compete in the 2026 US National Team Trials. Waivers will primarily be granted for injury or other similar incapacity or for a personal/family emergency. Requests for a waiver must be submitted in writing to the Director of National Teams as far in advance as possible.

5.3 NOMINATION TO THE TEAM:

Athletes will qualify for the 2026 Pan American Championships and World Para Taekwondo Championships Team by winning their respective K44 para taekwondo weight division at the 2026 U.S. National Team Trials. Athletes that finish as the runner will be considered the alternate and participate in team camps and the 2026 Pan American Championships and World Para Taekwondo Championships if allowed.

Athlete must be [internationally classified](#) in an eligible Sport Class with a Sport Class Status of (i) Confirmed; or (ii) Review with a Fixed Review Date of 2026 or later

- If an athlete is not yet [internationally classified](#), the athlete must be classified at the 2026 US Open Taekwondo Championships in Las Vegas, Nevada, March 4 – 8, 2026. WT Para Taekwondo Athlete Classification rules can be found at <https://www.worldtaekwondo.org/inside/PARA/Classification/Documents/contents>
- If the winner of the 2026 US Team Trials fails to classify by the US Open or is not classified by World Taekwondo, and if the runner-up is classified, this athlete will move to the National Team spot for 2026. The third place finisher at the 2026 US Team Trials will then move to the runner-up spot, as long as they are classified.

SECTION 7: MANDATORY TRAINING AND/OR COMPETITION

Athletes who win their division at the 2026 Para Taekwondo Team Trials will be named to the 2026 Para Taekwondo K44 National Team.

2026 Para Taekwondo National Team members and runner-up athletes will be required to attend the 2026 US Open Taekwondo Championships in Las Vegas, Nevada, March 5 – 8, 2026. In addition to the US Open, National Team members will also be required to attend, at minimum, one other WT G-Level event in 2026.

Athletes named to the 2026 Para Taekwondo National Team and the runner-up for each division will be required to attend three (3) of four (4) training camps held in the United States and train with the national team coaches and team. Once the World Para Taekwondo competition calendar is posted online, <https://www.worldtaekwondo.org/calendar/event-calendar/list?typeCd=PT&detailsKey=&year=2025&q=>, the USATKD High Performance staff will determine international tournaments and schedule training camps around these competitions. Athletes will be informed through email the dates and location of each camp.

Athletes that won or finished as the runner-up in their respective divisions at the 2026 U.S. National Team Trials will be fully funded to the Grand Prix Series tournaments. Any funding for athletes that did not finish first or second at the 2026 U.S. Team Trials is not guaranteed and will be provided, if available.

While waivers for mandatory training will not be unreasonably withheld, all athletes nominated to the Team should arrange for appropriate time off from school, work or other obligations in advance. Waivers will primarily be granted for injury or other similar incapacity or for a personal/family emergency. Requests for a waiver must be submitted in writing to the Eric Wining, Director of National Team as far in advance as possible. Requests must be submitted to ewining@usatkd.org at least two weeks before the start of camp. A physician (or medical staff) approved by USATKD will provide certification that the athlete has a debilitating condition and determine if the athlete should not attend the camp. Medical information will be submitted directly to the appointed physician or approved medical staff.

SECTION 8: DATE OF TEAM NOMINATION

NGB will nominate the Team, including any replacements/alternates following the conclusion of the 2026 U.S. National Team Trials (January 30 – February 1, 2026; Tulsa, Oklahoma).

SECTION 9: REMOVAL OF ATHLETES FROM THE TEAM

9.1 NGB JURISDICTION

NGB has jurisdiction over the 2026 Para National Team.

- a. An athlete who is nominated to the Team by NGB may be removed for any of the following reasons, as determined by NGB:
 - i. Voluntary withdrawal. Athlete submits a written letter to Eric Wining, the USATKD Director of National Teams, requesting to voluntarily withdraw from the Team. Submissions must be sent to ewining@usatkd.org.
 - ii. Injury or illness. A physician (or medical staff) approved by NGB provides certification that the Athlete has a debilitating condition. If Athlete refuses to provide verification of their illness or injury by a physician (or medical staff), their injury will be assumed to be debilitating, and they may be removed from the Team.
 - iii. Failure to participate. Athlete does not participate in all Mandatory Training and/or Competition as defined in these procedures.
 - iv. Code of Conduct Violation. Athlete violates the NGB Code of Conduct: <https://www.usatkd.org/v2-resources/code-of-ethics>
 - v. Athlete Agreement. Athlete violates a term in their signed NGB Athlete Agreement.
 - vi. Non-compliance. Athlete does not meet the athlete eligibility requirements listed in Section 3 and Section 4 of these selection procedures.

- b. An Athlete may be removed as a nominee to the Team or from the Team if found to have violated WT, WADA, USADA and/or USOPC anti-doping protocol, policies and procedures, the U.S. Center for SafeSport Code, the USOPC Athlete Safety Policy and NGB SafeSport policies, as applicable.
- c. Additional factors for Paralympic Athletes:
 - i. WT removes the event in which the athlete qualified for the Team from the medal event program.
 - ii. A change in the athlete's sport class(es) following Team selection such that the athlete's qualifying performance would not have qualified them for the Team and/or the athlete is deemed Not Eligible (NE) by the IPC or WT.
- d. Non-compliance with the eligibility requirements listed in Section 2.

SECTION 10: SELECTION PROCESS IF ATHLETE VACANCY OCCURS PRIOR TO SUBMISSION OF ENTRIES BY NAME TO THE LOCAL ORGANIZING COMMITTEE

- 10.1 Should a vacancy occur prior to submission of Entries by Name to the Local Organizing Committee, the first alternate (2nd place finisher in the respective K44 weight division at the 2026 U.S. National Team Trials) will be offered the vacant spot to compete at the 2026 Pan American Championships and World Para Taekwondo Championships.

Should the second place finisher decline their invitation, the position will be offered to the bronze medalist (3rd place finisher) from Team Trials that lost to the eventual gold medal winner, and then to the bronze medalist who lost to the alternate. Should all medalists decline the invitation, USATKD will not field a representative in that division.

- 10.2 All replacement athletes must meet all requirements listed in Sections 3-4.

SECTION 11: RIGHT TO A HEARING

An athlete who is removed from the Team has the right to a hearing per the NGB's complaint procedures ([found here](#)) and the USOPC Bylaws, Section 9 (www.usopc.org/governance/dispute-resolution).

SECTION 13: DISCLAIMERS

These procedures are based on WT rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in WT rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to the NGB.

However, the selection criteria are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency. If any force of nature, pandemic, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures may require revisions, pursuant to their resubmission to the USOPC.

SECTION 14: CONFLICT OF INTEREST

All members of the Selection Committee and all individuals who developed these selection procedures (Section 21) must comply with the USATKD Conflict of Interest Policy, to include completing and submitting a disclosure form consistent with the NGB's Conflict of Interest Policy before convening the committee.

[USATKD Conflict of Interest Policy](#)

A conflict of interest exists when a personal, family, financial, professional, club, team or business relationship or interferes with, or maybe perceived to interfere with a committee member's ability to be impartial and participate in the selection process in a fair and impartial manner. Any member of the Selection Committee who has an actual, possible, or perceived conflict of interest must disclose it to the NGB's [Ethics Committee] prior to the start of the selection process and may be required to recuse themselves from the Selection Committee discussions and/or voting.

If a conflict exists, the NGB's Ethics Committee shall review the conflict and determine the committee member's level of involvement (e.g., whether that committee member must recuse themselves from participating in discussions and/or voting).

During its review, the NGB Ethics Committee may ask a Selection Committee member or an affected person for more information at its discretion. For example, if a Selection Committee member is required to recuse themselves from voting, the NGB Ethics Committee may still determine that a Selection Committee member who has relevant and necessary information related to athlete performance, such as a national team coach or high performance director, may, if requested by the Selection Committee, provide that information to the Selection Committee if the information is provided in a fair and unbiased manner and if the Selection Committee member with the conflict of interest does not vote toward the final decision.

Additionally, any person with a good faith belief that a committee member has a conflict of interest may report the alleged conflict of interest to the NGB Ethics Committee, smcnally@usatkd.org. Reports may also be made anonymously through the [USOPC's Integrity Portal](#). No committee member shall retaliate in any way against a person who, in good faith, reports an alleged conflict of interest. In addition, the USOPC maintains a strict no retaliation policy that prohibits any employee, contractor, agent, volunteer, or member of the USOPC to take or threaten to take any action against an athlete for reporting information to or seeking assistance from the Office of the Athlete Ombuds.

Any recused individual shall be replaced in accordance with the NGB Selection Committee appointment process.



APPENDIX B – GLOSSARY

Contingency means a future event or circumstance which is possible but cannot be predicted with certainty.

Delegation Event means the Olympic Games, the Olympic Winter Games, the Paralympic Games, the Paralympic Winter Games, the Pan American Games, and the Parapan American Games.

Force Majeure means an event or effect that cannot be reasonably anticipated or controlled (e.g., hurricane, tornado, etc.).

Grievance Procedures means the process that enables an athlete to file a complaint with the NGB or USOPC.

Jurisdiction means the power or authority to make decisions and judgments.

Nominated means an athlete, coach or staff member whose name has been submitted to the USOPC by an NGB for participation in a Delegation Event.

Protected Competition means a Delegation Event or a Qualifying Competition.

Qualifying Competition means either of the following:

- i. **NGB Qualifying Competition:** Any competition or activity organized or approved by the NGB where the athlete's performance or results are considered in the published selection criteria to represent the United States in a Delegation Event.
- ii. **International Qualifying Competition:** Any international sport competition where (i) athletes represent the United States against athletes representing other nations, (ii) the NGB officially designates entrants, as required by the competition organizers, and (iii) athlete results or performance are included in the published criteria to qualify, or be selected, to represent the United States in a Delegation Event.

Selected means an athlete, coach or staff member whose name has been submitted by the USOPC to the OCOG at the final submission date, as determined by the OCOG.

USOPC's DRU oversees the administration of dispute resolution services to athletes and other members of NGBs for grievances under the USOPC's jurisdiction to ensure the complaints are heard in a timely and fair manner.
