Playing system

Men's Singles and Women's Singles will play Follow system:

- Qualifying System Round
- Stage 1
- Stage 2
- Stage 3

All matches in Qualifying System Round and Stage 1 are best of 5 games and all matches Stage 2 and Stage 3 are best of 7 games.

Reporting

All players need to report in the call area 25 minutes before the match.

Draws

Draws will be made at least one (1) day before each competition.

Technical Meeting

Organizing Committee will host a Technical Meeting on 03/20 at 7pm at the competition venue where Referee Team will go over the rules of the event, as well as players can voluntarily check their rackets.

Accreditation

All coaches will be required to have an accreditation to access the Field of Play. To be eligible for accreditation all coaches need to be fully Safe Sport Compliant and have a current criminal background check. All coaches will be required to request accreditation for 2024 US Olympic Team Trials – Table Tennis. For accreditation contact: tina.ren@usatt.org

Practice Schedule:

- o 8 Warm up tables will be available for players' that will compete, training schedule will be available on site after the draw.

- 4 practices tables will be available with a flexible schedule.
- Players shall only use tables in practice hall.
- No practice on match table.

Practice Area

Competition Area (FOP)

- 20 Mar: Opening hours: 12:00 – 20:00

Call area

During this tournament a call area is set up. Its functions are as follows.

- Players are to check-in 25 minutes before the scheduled match time.
 - Since matches are to start after previous match has completed (follow by system), players shall check-in when previous match has started third game.
- Player is to provide the name of the coach.
- Players are required to present their racket for testing a minimum of 10 minutes before the match. If a player fails to bring their racket on time, testing will be conducted after the match without the option for an appeal.
- In all matches, players are permitted to display a maximum of TWO logos on their playing shirt, adhering to the regulations specified for this event.
- Ball selection, 3 balls for each match
- If player does not present at the call 15 minutes before the match time, player loses the right of:
 - ball selection.
 - choose coach bench.
 - color of the shirt
- Players are asked to bring their bags to the bench latest 5 minutes before the march-in procedure will start.
- March in is planned for all days, more details at later time.

Field of Play

- During matches, up to 1 coach may sit at the bench.

- There will be official presentation before each session. All participants of the match shall be present at the Call Area 5 minutes before the scheduled match time to prepare for the march-in with the umpire. All players are obliged to follow this procedure.
- No cameras are allowed on the FOP.
- There is no practice allowed on competition tables during the event after the beginning of each session.

March-in

- Follow the instructions the Umpires regarding marching in.

Mixed Zone

- Players must go through Mixed Zone after they finish their matches in case they are asked.

Racket Testing

Official racket control will be applied in this competition following the international regulation. Matches will be chosen random; this racket control include:

- Official test for VOC
- Thickness and flatness control.

Uniform

All players are allowed to have a maximum of TWO logo on their playing shirt as follows: one brand logo and one club logo (club must be affiliated with USATT at least 6 months prior to the beginning of the event). Players are kindly asked to bring shirts that are compliant with this rule. Tape or other items may be used to conceal any non-permissible logos on an athlete's uniform.

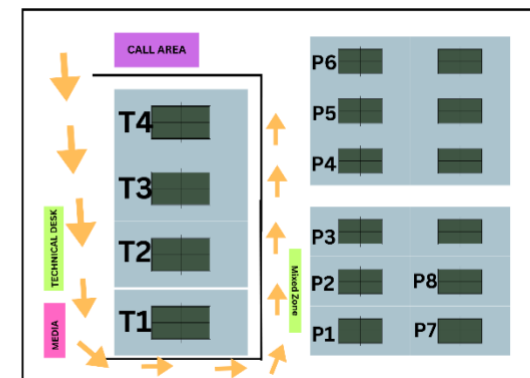
