The board consists of retired athletes, independent members and representatives from membership throughout the United States. US Speedskating governs both short track and long track speedskating.

Sport Development - US Speedskating provides athlete, coach, and official development programs to support the infrastructure of speedskating in the United States. This includes seminars and clinics, training camps, schools, and other such educational offerings.

Athlete development - US Speedskating provides complete training services and support for US National Team athletes. This includes providing the very highest caliber coaches, ice time, training support, and performance enhancements.
