 - Had strong representation between the R/Js and Doctors

Events & Boxing Operations Update - Mike Campbell, Boxing Operations & Events Manager:

- Upcoming Events:
 - National Qualifier: Cleveland, OH in 2 weeks (April 23rd)
 - **Lynette Smith:** Registration closes Tuesday, April 12. There will be a **late fee** added onto anyone who registers after that.
 - Minimum Bout requirement has been lowered for Elites so we can get more people in each weight class.
 - Make sure any walk-up officials are registered as well as any invited officials. If they would like to be in our hotel block please reach out to Kassie (Kmanguilli@usaboxing.org) with name, dates, and who is being billed so she can inform the hotel.
 - Check in will be Saturday the 23rd 12 PM (noon) - 8pm (Early check in Friday night)– if a coach shows up and is not registered, they will be asked to come back Monday, doing it on the spot will back the lineup, **BUT** they will still be able to get their athletes checked in at this time. Sunday will be the draw and there will be no check this day just seminars and clinics
 - Acceptance form will be reviewed by Campbell and McAtee within the week. Reach out if there are boxers that have trouble registering due to bout requirements, match tracker, or physicals
 - Ticketing will be through the box office – offering day passes, weekly passes, and passes for finals – Information can be found on our website (Credentials will also get you in the door)
 - COVID19 update: Masks and Vaccine checks are not mandatory
 - JO's Summer Fest: Wichita, KS (July 9th)
 - National Championships: Lubbox, TX
 - Announcement went out this week – please go read, there were a lot of changes made after evaluating everyone's 'after actions' from the last
 - Lubbock and Wichita have been great locations for the boxing community and will be used for alternating the JO's for years to come
 - International event: September 2022 Pueblo, CO
 - Also over lapping with 'Pikes Peak invitational' (regional event)
- USAB is starting to work on regional events, not run them but as an enhancement to help where needed (provide clinics and seminars for coaches and officials primarily)
- Train the Trainers series: ability to offer more bronze level clinics. Used to be just at national events but now we can come to LBCs, and currently are at USIBA & NBCA. Trying to assist with publicity

- There had been a handful of *FAKE* physicals – luckily our volunteer administrative staff that has been helping go through this paperwork & has caught them!

- Affidavit more compatible with boxers' restrictions – we are starting to put holds on athlete's accounts until a new affidavit is sent saying the boxer is now cleared. Please get that information to us ASAP so we put a hold on them before cleared.
 - If critical notify us right away!!
