#### **Entry Fee:**

<u>Judo</u> Early registered (Before September 1, 2024) - \$45 first division / \$20 second division <u>Judo</u> Late registration (Sept 2 – Sept 25<sup>th</sup>) - \$55 first division / \$25 second division (Only Weight Checks the day of the event. **Last chance to register will be Wednesday Sept 25th.** 

#### **General Information:**

**Eligibility:** Open to members holding current USA Judo or ATJA memberships. Proof of membership must be presented at weigh in. Save time and money by purchasing your USA Judo card on-line before you come to the tournament by going to <a href="www.usjudo.org">www.usjudo.org</a>. You will receive your card INSTANTLY and be able to bring it to the tournament.

Matches with 4 or less will be round robin and 5 or more will be double elimination. Judo Kansetsu-Waza will only be allowed in senior advanced and advanced master divisions.

**Awards:** 4" custom medals and neck ribbons for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place in each category. The traveling MO team trophy will be brought engraved with the winning team and given for that year.

#### There will be 2 mats.

Athletes make sure to have a white gi with both a blue belt and a white belt.

Weight classes will depend upon the number of entries. We will try to stay as close to national guidelines as possible. Registrations will be posted on the 26<sup>th</sup> and brackets will be posted the night of the tournament. Weight Checks/Check-ins will happen the morning of the tournament - <u>register for the weight you think you will make</u>. If you need to change notify the tournament director ahead of the tournament.

(Every effort will be made to provide every player an equable division. In the case of being uncontested, exhibition fights will be available.)

Senior Men Novice (under Sankyu): 130, 150, 170, 190, 210, 210+ Senior Women Novice (under Sankyu): 110, 130, 150, 170, 170+

Senior Men's Veterans: 30-39, 40-49, 50-59, 60+ (Divisions will be created based on registration.)

Senior Men's Veterans Novice: (30+ years with a rank of green or below) TBD

Senior Women's Masters: TBD

Senior Men: 60kg, 66kg, 73kg, 81kg, 90kg, 100kg, 100+kg Senior Women: 48kg, 52kg, 57kg, 63kg, 70kg, 78kg, 78+kg. Match Times Judo juniors and master 3 minutes and seniors 4 minutes

Junior Judo Divisions - male and female, novice (White to Orange) and advance (green to purple). **Novice division** is intended for novice players who have zero to limited tournament experience. Please abide by this when registering your athletes.

Judo Senior divisions – male and female, novice (green belt and below) and advanced (brown/black belt) Master's divisions will be determined by participation

MO Team Competition will be determined the day of the event. The teams will be divided by clubs on the east against clubs on the west.

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities ("Activity") of the USA Judo/United States Judo, Inc., Missouri Judo Inc, City of Joplin School District and Joplin Judo & Jiujitsu, I agree: 1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo. 2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate. 3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equip0ment used. Further, I acknowledge that there may be other risks not known or not reasonably foreseeable at this time. 4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death. 5.
