# **USA ROLLER SPORTS CERTIFICATE OF INSURANCE INFORMATION**

## **HOST AND VENUE LIABILITY INSURANCE AVAILABLE FOR USA ROLLER SPORTS CONTESTS ON DAILY BASIS.**

Events held within member club facilities are already covered by the Liability coverage, when all participants are current USA Roller Sports members. If a host party or host venue requires proof of coverage, USA Roller Sports will offer a Certificate of Insurance to any qualified applicant, by issuing a certificate naming the host party, host facility and/or any additional insured parties as covered under the policy. The liability insurance company is an A+ rated carrier. The criteria for this liability policy is that all participants in the competition must be individual members of USA Roller Sports, having signed a waiver of liability on the membership application. As a result, each competitor possesses the accompanying accidental injury indemnification insurance. A Certificate of Insurance covering the named co-insured can require 10 days for the insurance company administrative process and must be filed with USA Roller Sports accordingly.

The charge for the certificate is \$40 per liability insurance certificate covering the owners, the venue, the municipality or anyone else requiring such a document to approve the use of outdoor facilities. The certificate is a blanket certificate and covers chartered facilities for the competitive season. This expense must be prepaid and will be in addition to USA Roller Sports sanction fees.
