TOPICS DISCUSSED:

Operations:

Rule Book Revision - Andrew provided an update on prospective rule book revisions for 2024. A large focus will center around the classification and identification of sanctions, along with refining various definitions throughout the rulebook. Said revisions will take effect Jan 1, 2024.

Membership:

USA Boxing processed 727 new or returning memberships. Lynette expressed her gratitude to LBCs for working diligently to help our members become more self-sufficient, as the national office is working at capacity.

We asked LBCs to communicate to their members to wait 48 hours prior to contacting the national office about uploaded documents. This ensures USA Boxing can focus its efforts on processing documents.

Membership cards downloaded from Webpoint, are not printing properly. We will reach out to Webpoint for assistance. The issue should be resolved shortly.

High Performance:

Matt Johnson provided an update on our performance at the 2023 Pan-American Games in Santiago, Chile. Team USA took home 6 medals. Of the six boxers, five of them qualified for the 2024 Olympic Games in Paris, France. We still have eight weight classes that remain to qualify.

Matt further explained the qualification process between now and the end of the year. Team USA has two more opportunities to qualify, citing events in Italy and Thailand in 2024.

Pan American Games

Team USA won 6 medals and 5 athletes qualified for the 2024 Olympic games in Paris. There are eight remaining weight classes we are looking to qualify. There are upcoming Olympic qualifying events in Italy and Thailand in 2024.

Elite Selection Camp

USA Boxing will select two boxers in each weight category for camp. Boxers will be evaluated, based on certain criteria. Boxers with the highest scores will be selected.

Misc.

Coaching You Up

USA Boxing has grants for 140 events through early 2024. 70 of them have been awarded. USA Boxing is looking for 70 more events to apply. As a testimony to the program, we revealed the Illinois LBC hosting 10 of the 70 submitted thus far, earning \$10,000 for their LBC. Asked LBC leadership to apply for the program and take advantage of the available funding.

Election Updates

Voting is currently taking place, through November 14th. Simply voting will receive and verify votes. We hope to have the results posted by November 20. Each request has been verified, to ensure all voters have been properly vetted and their ballots verified. USA Boxing is following the voting process, as outlined in the LBC bylaws, to ensure proper elections procedures.

Officials Development

Angel Villarreal encouraged LBCs to send officials to national events. Nationals events are critical for development and improves officiating in the LBC. Explained the process on what an official can expect on how to when working.
