**PRELIMINARY NOTICE TO THE ATHLETE SELECTION PROCEDURES  
2027 Pan American Games**

March 9, 2026

To provide information in a timely manner, USA Team Handball is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2027 Pan American Games. This document is being written as a complement, and not a substitute to the 2027 Pan American Games Athlete Selection Procedures. Additional communication will be released by USA Team Handball once the Athlete Selection Procedures have been approved by the USOPC.

**A. Anticipated Athlete Eligibility Criteria:**

- Athletes must comply with all North American & Caribbean Handball Confederation and Pan American Sports Organization (PASO) eligibility requirements which will be posted here once available: [https://www.panamsports.org/en/documents/?doc\\_category=games](https://www.panamsports.org/en/documents/?doc_category=games)
- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all NGB, USADA, USOPC, WADA, and Panam Sports anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the [USOPC Background Check Policy](#) and [USOPC Athlete Safety Policy](#).

**B. PASO Qualification System Overview:**

- The anticipated maximum Team size will be fourteen (14) athletes.
- The 2027 Pan American Games Qualification Systems Manual for Handball has not been published by the IHF. It is anticipated that it will be posted here once available: [https://www.panamsports.org/en/documents/?doc\\_category=games](https://www.panamsports.org/en/documents/?doc_category=games)

**C. Anticipated Evaluation Events:**

- It is intended that athletes being considered for nomination to the 2027 Pan American Games will be evaluated on their performance at any of the below listed events. Please note that additional Evaluation Events will be added as dates and locations are confirmed. However, additional events are not expected to be added in advance of the August 2026 Pan American Games Qualifier.



