Flooring: Wooden gym floor

Clothing: USATT Dress Code applies

Rules: All USATT Regulations apply. Current USATT ratings as of the entry deadline will be used for rating purposes. Unrated players will be assigned an estimated rating.

Eligibility: Open by invitation only -- all players must be current USATT members or purchase membership/tournament pass in order to play.

Format: All games will be best of 5 games to 11 points. Singles will include 2 rounds of round robin play for all players. Doubles play will be determined on site depending on number of players and will occur between round 1 and 2 of singles.
