



### US Speedskating Event Sanction Form

Speedskating events held in the United States require a sanction from the National Governing Body of the sport, US Speedskating, in order to ensure a properly conducted event. Requirements for application are as follows:

**US Speedskating Event Sanctioning**

**Preventing Abuse Policy:**

The amateur sports organization or person requesting sanction US Speedskating will implement and abide by the policies and procedures to prevent the abuse, including emotional, physical, and child abuse, of amateur athletes participating in amateur athletic activities applicable to US Speedskating and must comply with all applicable Center of Safesport Requirements.

**What does “Event Sanctioning” mean?**

Event sanctioning means that the meet/event your organization is planning meets the requirements as outlined on the US Speedskating Event Sanction Form. Your meet/event is being recognized as an official meet.

**Is there a cost to obtaining a “Sanction”?**

There are no fees involved with this application process.

**US Speedskating always sanctioned events in the past. How come the change in Policy?**

US Speedskating wants to insure that your event will be run in a safe fashion, with qualified officials, and that the Racing Rules for Age Class Mass Start Competitions will be utilized, unless exceptions are published in the meet announcement. For your protection and for insurance reasons, we also want to make sure that all competitors are registered members of US Speedskating or are authorized to participate by their foreign country’s national governing body. Each participant must carry their own primary health insurance.

**What does it mean if US Speedskating does not sanction our event?**

If the event is not sanctioned, times earned by competitors participating in your event may not be used to satisfy the qualifying times needed for US Speedskating American Cup Races, Championship Events or other US Speedskating competitions. It is also recommended that your LOC carry some additional liability insurance during the course of the event as only sanctioned events have coverage under US Speedskating.

**What are the liability issues we should be aware of if our event is not sanctioned?**

There is no liability insurance under US Speedskating for a non-sanctioned event. A separate special event liability policy must be purchased by the organization sponsoring the event.

**Who can apply for sanctioning and how?**

The Meet Director from the applicant Club (which is within an Association), Direct Club, or Association that is a current member of US Speedskating, or a USOC/USOEC associated training venue or a venue where a US Speedskating sponsored National or Developmental team may apply for sanctioning. A form can be downloaded from the US Speedskating website ([www.usspeedskating.org](http://www.usspeedskating.org)).

**What are some policies that need to be implemented and followed?**

Your LOC will implement and abide by the policies and procedures to prevent the abuse, including emotional, physical, and child abuse of amateur athletes participating in amateur activities application to USS. The LOC must comply with the requirements of the Center for Safe Sport.

**Who determines whether our event will be sanctioned or not?**

US Speedskating determines whether your event will be sanctioned.

**How long does it take to obtain a sanction?**

Once a completed application form is received, US Speedskating will notify the Meet Director/applicant within 1 week. Your event will also be listed on the US Speedskating website on the schedule as a "USS Sanctioned Event".

**What happens if our event is sanctioned but at the last minute, the Chief Referee we had lined up cancelled?**

We recommend that you have at least one more Level 2 or above Referee as part of your officials team. For meets where skaters are trying to establish times for events listed above, trained officials must be part of your team. Your meet will be allowed to take place but qualifying times may not be accepted for USS Events unless Officials as outlined are working at your event.

**Can skaters use the One Day/One Dollar or the Introductory First-Time Two Month Trial Membership to compete at a sanctioned meet?**

No! The One Day/One Dollar membership is designed for those interested in speedskating who wish to give it a try for a brief time period (maximum 5 times) at any local club's practice. The Introductory First-Time Two-Month Trial Membership is designed to provide some additional time to try the sport. Both memberships are for non-competing skaters new to speedskating.
