

**NOMINEE FOR THE SPEED SKATING HALL OF FAME  
SKATER CATEGORY**

Classical Era (Long Track: Before 1964, Short Track: Before 1988)  
Modern Era (Long Track: 1964 to present, Short Track: 1988 to present)

A nominee to the Speed Skating Hall of Fame in the Classical Era category must meet the following minimum qualifications:

Achieved at least two (2) of the following criteria:

- A. Winner of 2 National or North American Senior Class Championships;
- B. National or North American Senior Class Records;
- C. Olympic or World Championship medalists;
- D. Olympic or World Records;
- E. Olympic Teams;
- F. World Teams

A nominee to the Speed Skating Hall of Fame in the Modern Era category must have achieved at least one of the following criteria five years or more prior to nomination:

- A. Senior World Championships
  - i. Member of at least four teams, achieving at least two top 15 finishes overall, or;
  - ii. Earning one individual medal or;
  - iii. Member of three relay or pursuit teams having won two medals
- B. Olympic Competition
  - i. Member of at least three teams, placing in the top 15 in one event, or;
  - ii. Member of at least one team, earning at least one individual medal, or;
  - iii. Member of at least two relay or pursuit teams winning two medals
- C. World Record Performance at an ISU sanctioned competition

The candidacy of each nominee will be judged on the nominee's record, ability, integrity, sportsmanship and character. All achievements and service must be documentable through sources such as National and/or International Records and Official Handbooks or news releases. Qualified applications will be considered for 5 years and may be re-submitted if there are any additional supporting qualifications.
