- \_\_\_\_ Non-skating complaint and one of eligibility without sufficient evidence or information advanced to justify further action.
- \_\_\_\_ Permitted the skater/official to participate under protest, referring the matter to USA Roller Sports (USARS) National Headquarters.
- \_\_\_\_ Reprimanded the skater/official protested.
- \_\_\_\_ Suspended the skater/official from event.
- \_\_\_\_ Disqualified skater/official from the remainder of the meet.

NOTE: USA Roller Sports (USARS) General Rule 10.04.02 provides the Referee-in-Chief with absolute control over the events being skated. The authority of the meet director shall not encroach upon the responsibilities of the referee.
