TOPICS DISCUSSED

Opening Remarks

- Mike McAtee opened the meeting thanking the membership and LBC leadership for their hard work. He reiterated our high membership numbers and gave a quick recap of our Olympic qualifying team.

Events

- Women's Championships
 - Discussed newly finalized details of the Women's Championship. The event will take place August in Lafayette, LA. It will be shortened to four competitions days. We will include open workouts, a hand mitt competition, and the gala. Last year, 85% of boxers had at least two bouts at the event, with some having six. The intent is to have everyone compete each of the four days.
- Junior Olympics/Summer Festival
 - This tournament is looking to break all records. Registration closed a week early with 1,100 boxers and 200 boxers waiting. LBC champions, and JO aged boxers will be prioritized. 70% of the 400 exemptions have been approved. Late fee for coaches begins 6/8/2024. Waitlists are being reviewed daily. We will have two sparring rings at the event. Sparring rules will be emailed prior to the event. Boxers will gather for opening ceremonies at 11:00 am on Sunday, to start at noon. Medaling ceremonies will take place June 29th.

Membership

- Discussed our USOPC's new deal with UPS for shipping discounts.
- Also, explained to LBC our the USOPC's auditing process surrounding athlete representatives. We will be reaching out to LBCs who don't have any athlete representatives and help them get seated
- Another reminder to not have members call about processing documents. Membership is working as fast as they can.

Operations

- Discussed the importance of continuing to report unsanctioned events. Thanked the New Jersey LBC for assisting in the sanctioning of an initially unsanctioned boxing event.

Finance

- LBCs not financially compliant for 2023:
 - LBC funds withheld until they comply
 - Three LBCs must submit all paperwork
 - Four LBCs are missing one or two items

Misc

- Many LBC officers have yet to submit a signed code of ethics form. LBC officers must submit this form ASAP. Form was uploaded during the meeting
- Medical Claims & Restrictions
 - All claims and restrictions will go to Stacy.
 - Restriction forms have been updated. Old forms will no longer be accepted. LBCs can place orders with membership for new forms.

Questions

- **Can an LBC use their funds to purchase a ring?**
 - If the ring can be used as a source of additional revenue (rental) or for the betterment of the LBC, then yes. We recommend the LBC review this matter and weigh their options.
- **When will Olympic team posters go out?**
 - We are currently working on finalizing the posters. They should be going out in the next few weeks.
- **How can LBCs combat last minute cancellations at local events?**
 - It's been recognized as a difficult scenario. The USA Boxing national office has begun placing walkover losses in the records of boxers who no call/no show. Recommended other LBCs to meet and discuss similar solutions better tailored to their LBC.
- **Is it required for documents to be uploaded?**
 - No. This is at the discretion of the LBC. However, many LBCs find it more convenient to have digitally verified documents.
