Declaration of Conflicts

- Patty: Coach for ODN and also parent of athlete trying out for team and Pan American, conflict for today's discussion of expedited coaching credentials
- Robin/Mikey/Kelly/Deb: Coach of athlete trying out for team & Pan Am
- Kelly: Coach of athlete trying out for World Team & Pan Am
- Tosha: volunteer for outdoor events in Florida, family runs the camera/timing system for ODN

National Team clarifications:

- US Citizens requirement must be on the document
- Timing for National Team calendar year would make it easier for invitations to fall clinics
- USOPC used to require us to fill out a PPA for number of spots, and may require time frame for National Team – ACTION ITEM: Patty will check with Ricci
- Tosha made a motion to use the calendar year as the National Team time frame, with allowance to fluctuate members in, Mary seconded. Motion passed unanimously.

ODN updates

- ODN panel/budget complete, trainer is not included as costs are unknown
- Tosha is working on the schedule. 200s will be Wednesday evening. Pan Am races must be run separately from ODN races. Tosha will look at 2018/2019 ODN schedules and send to SC for review (SC will have one day to review).
- Jay made a motion to use the 100m heats on the road to seed all the races. Kelly seconded.
- ACTION ITEM: Patty will put out an electronic vote.
- Note: IDN panel selection went to the board, waiting for approval, requested both IDN and ODN registrations be opened

Funding for National Team/World Team – grants

Patricia Harris will help us get large grants for Jr/Sr World Team – she is doing some pre-work to see
how our sport is helping young individuals physically/mentally. Jay should have an update next week.
She needs our coaches numbers/levels/beginner athletes/total athletes/special needs/females/ages.
ACTION ITEM: Jay will collect the information for her.

Expedited Coaching Credentials request

• Waiting period after level 1 is 1 year. 2 year waiting after level 2.

Comments from Speed Committee:

- There is a lot of learning that takes place once you become an official coach for that one year. Being a
 good skater does not mean that it automatically translates to being a good coach.
- What level coach you are does not demonstrate how good of a coach you are, no reason to rush to get to level 3.
- Having to go through the waiting period demonstrates a high level of commitment.
- How can we use newer coaches in camps/clinics: Level 1 coaches can volunteer to help coach/demonstrate – but may not be leaders, volunteering to coach at clinics will build coaching skills

ODN Selection Process

- Similar to Indoor World Team selection process should we have a process where there are multiple competitions to select the World team, so that it's not decided at 1 meet?
- SC will draft something up to present for feedback from membership
- ACTION ITEM: Patty will put proposal together

Brian Piccolo Park Update

Patty will be the point person to have the relationship with BPP for coating and chartering, in order to make BPP a certified location.

IDN Qualifier

- USARS has requested us to consider a qualifier
- Seeding is not working with no qualifier
- A qualifier will eliminate skaters and right now we need as many skaters at nationals as possible.

- ACTION ITEM: Patty will share concerns with USARS about impact of eliminating skaters from Nationals with a qualifier
- ACTION ITEM: SC to suggest process to assist with seeding Speed Committee discussion:
- Difficult to decide on how to make a timing system effective. Floor differences as one example, timing system as another.
- Use times from prior year nationals in the 500 (or?) to rank them, and anyone new would get a generic time based on division.
- ACTION ITEM: Patty will ask Regional Reps to weigh in with suggestions on ranking
