Meeting was called to order at 5:05pm EST.

- 1. Declaration of Conflicts
 - a. Many coaches and athletes on the call coach skaters who compete in these events or skate in the events.
- 2. Committee was reminded about confidentiality within the committee about business that we discuss.
- 3. Continuation of requirements discussions
 - a. Team dance discussion about possible change to 2 people or keep as one male and one female participant decide to keep as is and accept petitions as needed for non-binary athletes
 - i. Janet moved to Add to adult rulebook AR AD.114 "Petitions on the basis of gender identity can be submitted to the Artistic Sport Committee", John seconded. 5 approved, 1 abstention.
 - b. Lawaun moved to allow WS junior and senior figure skaters to skate A creative events, Jaymee seconded. Motion approved by acclamation.

- 4. Promotional World Skate Program
 - a. Briefly discussed pros and cons of adopting this program and how parts of it could be used or adapted in our B programs.
- 5. Elimination of Juvenile B
 - a. Discussed whether or not this is a big enough structural change that it would need to be passed through the board.
 - b. Discussed putting together a clear proposal for removing Juvenile B and why that could be shown to the field to get support for next season.
- 6. Splitting of Freshman/Sophomore B
 - a. Lawaun motioned to split Fresh/Soph B Women's Figures, Fresh/Soph B Women's Free Skating, and Fresh/Soph B Solo Dance. Janet Seconded.
 - i. Discussed potential pros and cons of the split including how it could affect the length of Nationals, how it could move more skaters out, how it would be hard to implement this change without changing sliding scale.
 - ii. Motion withdrawn on the recommendation that we draw up a B structure proposal to be put out at the beginning of the season so the field can provide feedback to implement for next season.
- 7. OCD max time limit
 - a. Janet motions to increase the max time to 2:30 from 2:15 for OCD. John seconded. Motion approved by acclamation.
 - i. Discussed pros and cons of decreasing from two rounds to one round.
 - ii. Conflicts were noted and all were allowed to vote.
- 8. Domestic Pairs
 - a. Discussed adding this to the proposals we send out for review to the field (see action items)
- 9. Trial events International Compulsory, Duet, and Classic Creative events
 - a. Discussed the purpose of the international compulsory event and how it helps promote international dance (into World Skate or for skaters who want to stay in domestic)
 - b. Discussed the pros and cons of creative duets and emphasized the potential to put all show events on or near the same day.
 - c. Classic Creative well attended and very competitive. Discussed making this event elimination/final since there is a rule stating that all classic events are final only (rule under discussion: AR AD.112 a All Classic Events will skate only a FINAL round regardless of number of entries.)
 - i. Janet motioned to replace rule AR AD.112 with the following wording: All international dance and all original compulsory dance events (team and solo) will be final only. Jodee seconded. Motion approved by acclamation.
- 10. Renaming World Skate events

- a. John motioned to remove the World Skate (WS) in front of the World Skate events, Kristen seconded. Motion approved by acclamation.
- 11. Renaming domestic precision events
 - a. Janet motioned to change the name of Novice Precision to Precision 12 & Up, change Junior Precision to Precision 15 & Under, and change Youth Quartet to Elementary Quartet. John seconded. Motion approved by acclamation.
- 12. Classic freestyle
 - a. Discussed if there is a need to put limits on this event or a split in this event.
- 13. Loop event
 - a. Discussed regrouping loop events and that this should be added to the proposal to go out to the field (see action items).
- 14. Figure requirements
 - a. Finalized
