

GUIDE TO USAT PROVIDED SIGNAGE:

Sign 1: “Ways to Report/Mandatory Reporting”

- This sign provides links to reporting mechanisms (directly to the Center for SafeSport and to USA Triathlon) for reporting all witnessed and suspected misconduct.
- Recommended to hang wherever possible.

Sign 2: “What should be reported?”

- This sign addresses what types of contact should be reported to either USA Triathlon or the Center for SafeSport.
- Recommended to hang wherever possible.

Sign 3: “In This Bathroom”

- This sign from the Center for SafeSport outlines rules for all port-a-potties and bathrooms at all sanctioned events.
- Recommended to hang near all bathrooms, locker rooms, and/or changing areas.

Sign 4: “Athletic Training Notice”

- This sign from the Center for SafeSport outlines rules for all athletic training areas.
- Recommended to hang near all areas where athletic care and treatment may occur.

Sign 5: “What is the MAAPP?”

- This sign summarizes what the Minor Athlete Abuse Prevention Policies are and how they protect minor athletes.
- Recommended to hang wherever possible.

Sign 6: “At This Event: 1-on-1 Interactions”

- This sign from the Center for SafeSport establishes rules for contact with any minor athletes at events.
- Recommended to hang wherever possible.

Sign 7: “Does the MAAPP Apply to You?”

- This sign from the Center for SafeSport establishes who the Minor Athlete Abuse Prevention Policies (MAAPP) rules apply to.
- Recommended to hang wherever possible (optional).



If you witness any type of abuse or violations of the MAAPP, you must report it.

What should be reported?

Allegations of Abuse

- Witnessed Bullying, Physical, Sexual, Emotional, and/or Child Abuse
- Any Suspicion of Abuse

Violations of the MAAPP

- Any 1-on-1 interaction with a minor athlete that is not observable and interruptible
- Photography/recording in bathroom or changing areas
- Any treatment that puts a minor in danger

What is the MAAPP?

- A collection of proactive prevention and training policies for the U.S. Olympic & Paralympic movement.

Key Points of the MAAPP

- Any 1-on-1 interaction with a minor athlete must be observable and interruptible
- Any treatment requires that another Adult Participant is always in the room
- Adults may not recklessly or intentionally change in a way that exposes themselves in front of minors
- All electronic communications between minors and adults must include another Adult Participant
- All policies must be followed during all lodging and transportation related to the event
