RE: Preliminary Notice to the Junior Women’s Athlete Selection Procedures for the 2025 Junior Pan American Games and the 2025 Junior World Cup

To provide as much information in a timely manner, USA Field Hockey is releasing this Preliminary Notice to the Junior Women’s Athlete Selection Procedures for the 2025 Junior Pan American Games (August 9-23, 2025), and the 2025 Junior World Cup (dates are not yet determined). This document is being written as a complement, and not a substitute to the 2025 Junior Pan American Games and the 2025 Junior World Cup Junior Women’s Athlete Selection Procedures.

At this time, USA Field Hockey has determined that it will participate in the 2025 Junior Pan American Games and the 2025 Junior World Cup.

**A. Anticipated Evaluation Events:**

- It is intended that athletes being considered for nomination to both the 2025 Junior Pan American Games and the 2025 Junior World Cup will be evaluated on their performance at the USA Field Hockey U21 Junior Women’s National Team (JWNT) 2025 Selection Camps and Training Camps, as well as the 2025 Senior Nexus Championships.
- Should the 2025 Junior World Cup be held in December of 2025, the 2025 Junior Pan American Games will serve as an additional evaluation opportunity for athletes to be selected to the team for that event.



