Steve McNally, CEO

Mr. McNally mentioned that there is a positive cash surplus that will be moved to generate additional income to secure the future of USA Taekwondo. He has two potential bank partners that are interested in working with USA Taekwondo. In addition, he is in discussions to possibly partner with a freight company and a payment processing entity. His role will be moving more towards securing sponsorships and partnerships that will benefit USA Taekwondo. USA Taekwondo may bid on the 2027 WT World Taekwondo Championships. He is primarily looking at the west for this event, and particularly the Los Angeles area. This would be a great lead in event prior to the LA28 Olympic & Paralympic Games. The World Military Games have been awarded Charlotte in 2027. He has a small group looking into possible NCAA status for USA Taekwondo.

Christine Strong Simmons – Finance, Membership & Event Updates

Financials

- Cash flow is currently higher than projected due to end of 2024 positive net revenue, a new sponsor, better than anticipated US Open, East, West, and State competition registrations.
- The budget is on track with forecasted revenue.

Membership

Membership increased 11% in 2025
